RESOLUTION NO. 2021-353

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE PURCHASE OF RESIDENTIAL RECYCLING BINS TO PENINSULA PLASTICS LIMITED DBA NOVA PRODUCTS, THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN THE INITIAL AMOUNT OF \$195,200.00, PURSUANT TO INVITATION TO BIDS (IFB) 2021-035 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on October 26, 2021, the Procurement Division of Finance formally advertised, issued and distributed the IFB for Residential Recycling Bins; and

WHEREAS, ten (10) prospective bidders downloaded the IFB package from Public Purchase, the City's web-based e-Procurement service; and

WHEREAS, on November 16, 2021, two (2) bids were received in response to the IFB 2021-0351 from Orbis Corporation and Peninsula Plastics Limited dba Nova Products; and

WHEREAS, the Public Works Department concurs with the Procurement Officer's recommendation to award the Residential Recycling Bins purchase to Peninsula Plastics Limited dba Nova Products; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer authorizing the City Manager to award the Residential Recycling Bins purchase to Peninsula Plastics Limited dba Nova Products, the lowest responsive and responsible bidder in the initial amount of \$195,200.00, pursuant to Invitation for Bids (IFB) 2021-035 and Section 2-763 of the procurement code entitled "contract

award"; further authorizing the purchase of additional units based on the available budget.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
