

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2024-277**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF A \$20,000 GRANT FROM THE VILLAGERS FOR THE INSTALLATION OF SOLAR PANELS ON THE ROOF OF THE GRANADA DINER LOCATED AT 2001 GRANADA BOULEVARD; AUTHORIZING THE CITY MANAGER TO EXECUTE THE GRANT AGREEMENT WITH THE VILLAGERS; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2024-2025 ANNUAL BUDGET TO RECOGNIZE THE FUNDS AS REVENUE AND APPROPRIATE SUCH FUNDS TOWARDS THE COST OF THE PROGRAM.

**WHEREAS**, the City has received a grant from the Villagers in the amount of \$20,000 for the installation of solar panels on the roof of the Granada Diner located at 2001 Granada Boulevard; and

**WHEREAS**, this grant was made possible by a generous donation of \$20,000 from Sallye Jude to the Villagers; and

**WHEREAS**, the installation of solar panels at the Granada Diner is in alignment with the City's sustainability goals of building a more sustainable and resilient City for current and future generations; and

**WHEREAS**, provided the City receives all necessary approvals for the installation of the solar panels, the City wishes to accept this grant;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The City Commission does hereby authorize the acceptance of the \$20,000 grant from The Villagers contingent on the City receiving all necessary approvals for the installation of the solar panels.

**SECTION 3.** That the City Manager is authorized to negotiate and execute a grant agreement with The Villagers in a form acceptable to the City Attorney, and to execute any subsequent extensions, amendments, or modifications to the grant agreement with the organization.

**SECTION 4.** The City Commission hereby authorizes an amendment to the Fiscal Year 2024-2025 Annual Budget to recognize the \$20,000 grant as revenue and to appropriate the funds for the solar panel installation program at the Granada Diner.

**SECTION 5.** That this Resolution shall become effective upon the date of its passage and adoption herein.




