RESOLUTION NO. 2025-360

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA, RELATING TO THE PROVISION OF STREET LIGHTING SERVICES, FACILITIES AND PROGRAMS WITHIN THE COCOPUM PHASE I STREET LIGHTING SPECIAL TAXING DISTRICT; PROVIDING AUTHORITY, DEFINITIONS AND INTERPRETATION; CONFIRMING THE PRELIMINARY ASSESSMENT RESOLUTION; APPROVING THE UPDATED STREET LIGHTING ASSESSMENT ROLL; PROVIDING FOR THE REIMPOSITION OF THE STREET LIGHTING ASSESSMENTS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2025; PROVIDING FOR COLLECTION OF THE ASSESSMENTS PURSUANT TO THE UNIFORM ASSESSMENT COLLECTION ACT; PROVIDING FOR THE APPLICATION OF ASSESSMENT PROCEEDS; PROVIDING FOR THE EFFECT OF THIS RESOLUTION; PROVIDING CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Coral Gables, Florida (the "City Commission"), has enacted Ordinance No. 2015-09, the Master Service Assessment Ordinance (the "Assessment Ordinance"), which authorizes the annual reimposition of Street Lighting Assessments for street lighting services, facilities, and programs; and

WHEREAS, the imposition of a Street Lighting Assessment for street lighting services, facilities, and programs each fiscal year is an equitable and efficient method of allocating and apportioning Street Lighting Service Cost among Parcels/Folios of Assessed Property; and

WHEREAS, the City Commission desires to reimpose a Street Lighting Assessment within the Cocoplum Phase I Street Lighting Special Taxing District using the tax bill collection method for the Fiscal Year beginning on October 1, 2025; and

WHEREAS, on May 20, 2025, the City Commission adopted Resolution No. 2025-178 (the "Preliminary Assessment Resolution"), containing and referencing a brief and general description of the street lighting services, facilities and programs to be

provided to Assessed Property; describing the method of apportioning the Street Lighting Service Cost to compute the Street Lighting Assessment for street lighting services, facilities, and Assessed Property; estimating the rate of assessment; and directing the preparation of the updated Street Lighting Assessment Roll and provision of the notice required by the Assessment Ordinance; and

WHEREAS, the Assessment Ordinance requires the City Commission to adopt an Annual Assessment Resolution which confirms or repeals the Preliminary Assessment Resolution with such amendments as the City Commission deems appropriate, establishes the rates of assessment, and approves the Street Lighting Assessment Roll for the upcoming Fiscal Year after hearing comments and objections of all interested parties; and

WHEREAS, the Street Lighting Assessment Roll has heretofore been made available for inspection by the public, as required by the Assessment Ordinance; and

WHEREAS, notice of a public hearing has been published as required by the terms of the Assessment Ordinance, which provides notice to all interested persons of an opportunity to be heard; an affidavit regarding the form of notice mailed being attached hereto as Appendix A and the proof of publication being attached hereto as Appendix B; and

WHEREAS, a public hearing was held on September 12, 2025, and comments and objections of all interested persons have been heard and considered as required by the terms of the Assessment Ordinance;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA, AS FOLLOWS:

SECTION 1. AUTHORITY. This Resolution is adopted pursuant to the provisions of the Assessment Ordinance; the Initial Assessment Resolution (Resolution No. 2022-142); the Final Assessment Resolution (Resolution No. 2022-222); the Preliminary Assessment Resolution; Article VIII, Section 2, Florida Constitution; section 166.021, Florida Statutes; the Charter of the City of Coral Gables; and other applicable provisions of law.

SECTION 2. DEFINITIONS AND INTERPRETATION.

(A) This Resolution constitutes the Annual Assessment Resolution as defined in the Ordinance.

(B) All capitalized terms in this Resolution shall have the meanings defined in the Assessment Ordinance, the Initial Assessment Resolution, the Final Assessment Resolution, and the Preliminary Assessment Resolution.

(C) Unless the context indicates otherwise, words imparting the singular number, include the plural number, and vice versa; the terms "hereof," "hereby," "herein," "hereto," "hereunder" and similar terms refer to this resolution; and the term "hereafter" means after, and the term "heretofore" means before, the effective date of this resolution. Words of any gender include the correlative words of the other genders, unless the sense indicates otherwise.

SECTION 3. CONFIRMATION OF PRELIMINARY ASSESSMENT RESOLUTION. The Preliminary Assessment Resolution is hereby confirmed.

SECTION 4. APPROVAL OF ASSESSMENT ROLL.

(A) The Street Lighting Assessment Roll, a copy of which was present or available at the public hearing by electronic media and incorporated herein by reference, is hereby approved.

(B) Additionally, the Street Lighting Assessment Roll, as approved, includes those Parcels/Folios of Assessed Property within the Cocoplum Phase I Street Lighting Special Taxing District that cannot be set forth in that Street Lighting Assessment Roll due to the provisions of Section 119.071(4), Florida Statutes, concerning exempt “home addresses.”

SECTION 5. REIMPOSITION OF ASSESSMENTS TO FUND STREET LIGHTING SERVICES.

(A) The Parcels/Folios included in the Street Lighting Assessment Roll are hereby found to be specially benefited by the provision of the street lighting services, facilities, and programs in the amount of the annual Street Lighting Assessment set forth in the updated Street Lighting Assessment Roll.

(B) Adoption of this Annual Rate Resolution constitutes a legislative determination that all Tax Parcels/Folios assessed derive a special benefit in a manner consistent with the legislative declarations, determinations and findings as set forth in the Ordinance, the Initial Assessment Resolution, and Preliminary Assessment Resolution from the Street Lighting Services to be provided and a legislative determination that the Assessments are fairly and reasonably apportioned among the properties that receive the special benefit as set forth in the Preliminary Assessment Resolution.

(C) For the Fiscal Year commencing October 1, 2025, the estimated Street Lighting Service Cost for the Cocoplum Phase I Street Lighting Special Taxing District is \$90,650.00. For the Fiscal Year commencing October 1, 2025, the Street Lighting Assessment is \$608.25 per Lot/Unit. The annual Street Lighting Assessments computed in the manner set forth in the Preliminary Assessment Resolution are hereby levied and reimposed on all Parcels/Folios included in the updated Street Lighting Assessment Roll for the Fiscal Year commencing October 1, 2025.

(D) The methodology set forth in Section 5 of the Preliminary Assessment Resolution for computing the annual Street Lighting Assessments is hereby approved.

(E) Upon adoption of this Annual Assessment Resolution, the Street Lighting Assessments shall constitute a lien against the assessed property equal in rank and dignity with the liens of all state, county, district or municipal taxes and other non-ad valorem assessments. Except as otherwise provided by law, such lien shall be superior in dignity to all other liens, titles, and claims until paid. The lien shall be deemed perfected upon adoption by the City Commission of this Annual Assessment Resolution and shall attach to the property included on the Assessment Roll as of the prior January 1, the lien date for ad valorem taxes.

SECTION 6. COLLECTION OF ASSESSMENTS.

(A) The Street Lighting Assessments shall be collected pursuant to the Uniform Assessment Collection Act, as provided in the Ordinance.

(B) The Street Lighting Assessment Roll, as herein approved together with the correction of any errors or omissions as provided for in the Assessment Ordinance,

shall be delivered to the Tax Collector for collection using the tax bill collection method in the manner prescribed by the Assessment Ordinance.

(C) The Street Lighting Assessment Roll, as delivered to the Tax Collector, shall be accompanied by a Certificate to Non-Ad Valorem Assessment Roll in substantially the form attached hereto as Appendix C. The Property Appraiser and Tax Collector shall apply the Street Lighting Assessment rates approved herein to any Tax Parcels of Assessed Property with exempt “home addresses” pursuant to Section 119.071(4), Florida Statutes.

SECTION 7. APPLICATION OF ASSESSMENT PROCEEDS. Proceeds derived by the City from the Assessments will be utilized for the provision of Street Lighting Services within the District. In the event there is any fund balance remaining at the end of the Fiscal Year, such balance shall be carried forward and used only to Street Lighting Services within the District.

SECTION 8. EFFECT OF ANNUAL ASSESSMENT RESOLUTION. The adoption of this Annual Assessment Resolution shall be the final adjudication of the issues presented herein and in the Preliminary Assessment Resolution (including, but not limited to, the method by which the Assessments are computed, the Street Lighting Assessment Roll, the levy and lien of the Assessments, and the special benefit to assessed property) unless proper steps are initiated in a court of competent jurisdiction to secure relief within 20 days from the date of the City Commission action on this Annual Assessment Resolution.

SECTION 9. CONFLICTS. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 10. SEVERABILITY. If any clause, section or provision of this Resolution shall be declared unconstitutional or invalid for any reason or cause, the remaining portion of said Resolution shall remain in full force and effect and be valid as if such invalid portion thereof had not been incorporated herein.

SECTION 11. EFFECTIVE DATE. This Resolution shall take effect immediately upon its passage and adoption herein.

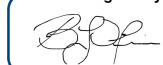

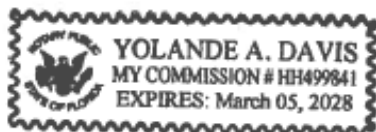

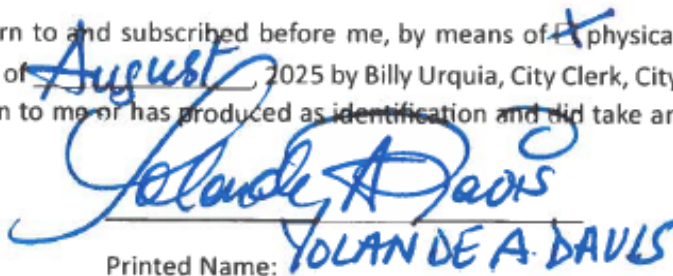

NOTICE OF HEARING TO IMPOSE AND PROVIDE FOR COLLECTION OF STREET LIGHTING SPECIAL ASSESSMENTS



COCOPLUM PHASE ONE
STREET LIGHTING SPECIAL TAXING DISTRICT

Notice is hereby given that the City Commission of the City of Coral Gables, Florida (the "Commission") will conduct a public hearing to consider the continued imposition of special assessments for the provision of street lighting services, facilities, and programs for the Fiscal Year beginning October 1, 2025 and future fiscal years within the boundaries of the Cocoplum Phase I Street Lighting Special Taxing District (the "District"), which includes all lands shown on the map set forth above. In the past, the District was established and governed by Metropolitan Dade County, but was transferred to the City of Coral Gables.

The hearing will be held at 9:00 a.m. on September 12, 2025, in the City Commission Chambers, 405 Biltmore Way, Coral Gables, Florida, for the purpose of receiving public comment on the imposition and collection of the assessments on the ad valorem tax bill. All affected property owners have a right to appear at the hearing and to file written objections with the City Commission within 20 days of this notice. If a

person decides to appeal any decision made by the City Commission with respect to any matter considered at the hearing, such person will need a record of the proceedings and may need to ensure that a verbatim record is made, including the testimony and evidence upon which the appeal is to be made.

Any person who needs assistance in another language in order to speak during the public hearing or public comment portion of the meeting should contact the City's ADA Coordinator Raquel Elejabarrieta, Esq., Director of Human Resources (E-mail: relejabarrieta@coralgables.com, Telephone: 305-722-8686, TTY/TDD: 305-442-1600), at least three (3) business days before the meeting.

Any person with a disability requiring communication assistance (such as a sign language interpreter or other auxiliary aide or service) in order to attend or participate in the meeting should contact the City's ADA Coordinator Raquel Elejabarrieta, Esq., Director of Human Resources (E-mail: relejabarrieta@coralgables.com, Telephone: 305-722-8686, TTY/TDD: 305-442-1600), at least three (3) business days before the meeting.

The assessment for each parcel of property will be based upon the total number of lots/units attributed to that parcel. The annual assessment will include each Tax Parcel/Folio's share of the service cost, plus administrative and collections costs. The maximum annual assessment is estimated to be \$608.25 per Lot/Unit. A more specific description is set forth in the Amended and Restated Initial Assessment Resolution (Resolution No. 2022-142) and the Amended and Restated Final Assessment Resolution (Resolution No. 2022-222. Copies of the Master Capital Project and Service Assessment Ordinance, the Amended and Restated Initial Assessment Resolution, the Amended and Restated Final Assessment Resolution, the Preliminary Assessment Resolution and the updated Assessment Roll are available for inspection at the office of the City Clerk, 405 Biltmore Way, Coral Gables, Florida.

The assessments will be collected on the ad valorem tax bill to be mailed in November 2025, as authorized by Section 197.3632, Florida Statutes. Failure to pay the assessments will cause a tax certificate to be issued against the property which may result in a loss of title. Unless proper steps are initiated in a court of competent jurisdiction to secure relief within 20 days from the date of City Commission action at the above hearing (including the method of apportionment, the rate of assessment and the imposition of assessments), such action shall be the final adjudication of the issues presented.

1. Diana M. Gomez, as Finance Director of the City of Coral Gables, Florida ("City"), pursuant to the authority and direction received from the City Commission, timely directed the preparation of the Assessment Roll and the preparation, mailing, and publication of notices as required by Ordinance No. 2015-09 (the "Assessment Ordinance") and in conformance with Resolution No. 2025-178 (the "Preliminary Assessment Resolution").

Governmental Management Services has caused the notices required by the Ordinance to be prepared in conformance with the Preliminary Assessment Resolution. An exemplary form of such notice is attached hereto. Governmental Management Services has caused such individual notices for each affected property owner to be prepared and each notice included the following: the purpose of the assessment; the total amount proposed to be levied against each parcel; the unit of measurement to be applied against each parcel to determine the assessment; the number of such units contained within each parcel; the total revenue the City expects to collect by the assessment; a statement that failure to pay the assessment will cause a tax certificate to be issued against the property which may result in a loss of title; a statement that all affected property owners have a right to appear at the hearing and to file written objections with the local governing board within 20 days of the notice; and the date, time, and place of the hearing.

3. On or before August 22, 2025, Government Management Services caused the mailing of the above-referenced notices in accordance with the Assessment Ordinance and the Preliminary Assessment Resolution by First Class Mail to each affected owner, at the addresses then shown on the real property assessment tax roll database maintained by the Miami-Dade County Property Appraiser for the purpose of the levy and collection of ad valorem taxes.

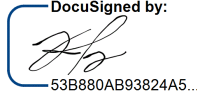
