

Engmann was walking toward the East side of the residence when he noticed a second male suspect (Suspect 2) climbing over a fence in the rear yard. Officer Engmann gave loud verbal commands to stop fleeing and was able to stop and detained Suspect 2 without further incident. Suspect 2 was subsequently read Miranda and waived his right to remain silent. Suspect 2 admitted to committing a burglary along with Suspect 1.

During a canvass of the surrounding area, Suspect 1's vehicle was located. It was parked on the grassy swale, directly across the street from the residence which they had just burglarized. While officers conducted an inventory of the vehicle prior to towing it, various property items were discovered inside the vehicle. Further investigation revealed the property belonged to two additional burglary victims who live in the City of Miami and Miami-Dade County jurisdictions.


Suspect 1 and Suspect 2 were arrested and charged with committing a residential burglary, and additionally charged for 2 more burglaries in the City of Miami, and Miami-Dade County, by each respective law enforcement agency.

I believe that the quickly established perimeter which led to the successful apprehension of both burglary suspects, is directly attributed to Officer James Coleman's diligent patrolling of his assigned zone, and fast response. Officer Coleman's strong work ethic, loyalty, commitment and dedication should be commended. Officer Coleman takes great pride in deterring crime, protecting and serving the residents in his assigned zone. Officer Coleman always goes out of his way to make his presence known and felt by the residents who live there.

For all the aforementioned reasons, I am very excited and honored to nominate Officer James Coleman for the prestigious Coral Gables Police Department Officer of The Month Award.

Narrative:

On December 7, 2022, at approximately 1343, I was dispatched to 1143 Obispo Avenue in reference to a bona fide burglar alarm via ADT Security (Involved Other 1).

Officer J. Coleman arrived prior to my arrival and approached the front door of the residence. Officer Coleman then verified the front door of the residence was secured and moved to the gate leading to the rear of the residence located on the west side of the property. Upon looking through the gate of the residence, Officer Coleman observed Mr. Damian Vado (Offender 1) crouched down in the northwest corner of the property. Officer Coleman observed Mr. Vado wearing a pink hoodie sweatshirt, gloves, and a full mask. Officer Coleman then opened the gate and gave Mr. Vado verbal commands to show his hands. Mr. Vado then fled northwest from Officer Coleman by jumping over the wall of the above listed residence.

Additional CGPD units then arrived on scene and set up a perimeter. Mr. Vado was subsequently apprehended by Officer J. Gonzalez at the 1100 block of Sorolla. While on a perimeter post in front of the above listed residence, Officer A. Engmann observed Mr. Jonathan Suarez (Offender 2) jumping over the east side fence of the above listed residence. Mr. Suarez was then taken into custody by Officers A. Engmann, J. Coleman, A. Ferrufino, and F. Diaz.

Mr. Vado and Mr. Suarez were interviewed by CGPD Detectives K. Taha and W. Diaz. Mr. Vado waived his Miranda Rights and subsequently confessed to committing the residential burglary with Mr. Suarez.

Mr. Vado and Mr. Suarez were arrested. Mr. Vado was transported to TGK via CGPD processing. Mr. Suarez was transported to the JAC via CGPD processing.

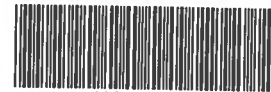

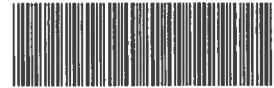

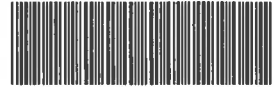
