## **ORDINANCE NO. 2023-10**

AN ORDINANCE OF THE CITY COMMISSION AMENDING THE CITY CODE. CHAPTER I-GENERAL PROVISIONS. SECTION 1-7 ENTITLED "PENALTIES" TO INCLUDE ADDITIONAL PENALTIES FOR VIOLATIONS OF SECTION "MOTORIZED 74-241. **SCOOTERS** ENTITLED SIDEWALKS" SECTION 74-2 "PROHIBITING AND SKATEBOARD USE GENERALLY:" PROVIDING FOR PROVISION. SEVERABILITY REPEALER CLAUSE. CODIFICATION, AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** Section 74-241 of the City Code currently allows the riding of motorized scooters upon all sidewalks located within the city, except where prohibited by official posting; and

**WHEREAS,** Section 74-2 of the City Code prohibits skateboarding on the city's public sidewalks where posted; and

**WHEREAS**, currently Miracle Mile, Giralda Ave, and certain blocks of Ponce de Leon Boulevard have official City postings prohibiting the riding of bicycles, scooters, and skateboards; and

**WHEREAS**, there has been an increase in concern regarding prohibited riding of bicycles, scooters, and skateboards and potential harm to pedestrians; and

**WHEREAS,** the City Commission has recently adopted on first reading an ordinance increasing and amending the fines for bicycle riding where prohibited; and

**WHEREAS,** the City Commission wishes to amend the Code to mirror those fines for violations of Section 74-241 and 74-2 of the City Code; and

**WHEREAS,** in order to increase deterrence, the City wishes to add specific increased penalties for violations of Section 74-241 and Section 74-2 and bring the penalties in line with similar violations; and

**WHEREAS,** this ordinance amends Chapter 1 "General Provisions", Section 1-7 "Penalties" of the official City Code in order to include penalties for violations of Section 74-241 and Section 74-2;

## NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

**SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption hereof.

**SECTION 2.** Chapter 1 "General Provisions" - Section 1-7 "Penalties" is amended as follows: <sup>1</sup>

City Code §	Description of Violation	Penalty
CC 74-2	Prohibited skateboard use.	\$35.00 fine for the first violation;  \$100.00 fine for the second violation;  \$200.00 fine for third or
CC 74-241	Motorized scooters on sidewalks	subsequent violations \$35.00 fine for the first
<u>CC 74-241</u>	Motorized scoolers on sidewarks	violation;  \$100.00 fine for the second violation;
		\$200.00 fine for third or subsequent violations

**SECTION 3.** All ordinances or parts of ordinances inconsistent or in conflict with the provisions of this Ordinance are hereby repealed.

**SECTION 4.** If any section, part of section, paragraph, clause, phrase or word of this Ordinance is declared invalid, the remaining provisions of this Ordinance shall not be affected.

**SECTION 5.** It is the intention of the Commission of the City of Coral Gables, Florida, that the provisions of this Ordinance shall become and be made part of the City of Coral Gables Code of Ordinances; and that the sections of this "ordinance" may be changed to "section", "article", or such other appropriate word or phrase in order to accomplish such intentions.

**SECTION 6.** If the Official Code of the City of Coral Gables Tables of Contents or other reference portions is affected by these provisions, then changes are approved as a part of this Ordinance.

**SECTION 7.** This Ordinance shall become effective immediately upon its passage and adoption herein.
