

SUMMARY STATEMENT OF SIGNIFICANCE

Columbus Boulevard, a major traffic artery in the city was designed to showcase beautiful homes, typically occupying two lots, with some of the largest early residences in Coral Gables. While the architect for this home has yet to be identified, it clearly reflects the quintessential elements of Mediterranean design, and commands a striking presence on the boulevard.

BACKGROUND

The Country Club Section Part One subdivision was platted in December 1923. W. C. Bliss, the Coral Gables Corporation's civil engineer laid out the meandering boulevard with its wide street as an integral part of the network of intersecting boulevards.



One of the most scenic boulevards in the city, the street features a lush canopy created by mature ficus trees.

CRITERIA FOR SIGNIFICANCE

I. Embodies those distinguishing characteristics of an architectural style, or period, or method of construction. (Coral Gables City Code, Chapter 11, Section 11-29(2)(b)

This home is an archetypal example of the design we have come to call Mediterranean Revival. This striking residence expresses a masterful combination of one and two-story sections, that in some cases terminate in towers.

The complexity of the design is further demonstrated by a combination of roof types and slopes; tile coping which defines the edges, and the use of coral rock accents to focus the round arches of the front porch on the primary elevation. That first floor porch is a particularly beautiful element of the design when contrasted with the two-story portions of the residence.

ADDITIONS/ALTERATIONS

Addition:

In 1983, a 498 square foot addition was made to the residence. The addition was appended to the south end of the main elevation and then extended east, towards the back of the lot. The addition contains a master bathroom and two walk-in closets. The addition, designed by Hersh and Associates, steps back from the main wall plane and beautifully compliments the original architecture.

It is the staff's opinion that the addition does not adversely affect the integrity of the original residence.

Alterations:

The coral rock lined arcade was once completely open, and has since been glazed. The infilling of the space <u>did</u> <u>not</u> alter any dimensions, and as it is a transparent material, still conveys the sense of the space.

STAFF RECOMMENDATION

This residence is a magnificent example of the quality and character built into the design of Coral Gables' early homes. The residence may be considered archetypal in its expression of the hallmarks of the "Mediterranean Revival" style of architecture, which gives Coral Gables its unique place in Florida's boomtime history.

The staff therefore recommends the residence at 2907 Columbus Boulevard for listing in the Coral Gables Register of Historic Places.








Photograph c.1945 (before Addition)
