Dear Property Owner and/or Occupant:

As part of an ongoing effort to enhance the health, safety, and welfare of the citizens of Coral Gables, a recent inspection was made of the premises at **8150 OLD CUTLER RD, Coral Gables, FL.**

At that time, a Code Enforcement Officer found the following violation(s) evident on the property:

Violation(s):

- **Placing and/or maintaining obstructions on the public right-of-way, which is prohibited: City Code - Chapter 62, section 62-153(B). Remedy by: Obtaining necessary approval and permit from the Public Works Department or remove said obstruction.**
- Violation of Coral Gables Zoning Code.**

Code Enforcement Officer Comments: Property painted without color pallet approval.

Hedge installed on the City right of way without approval and permits.

The following steps should be taken to correct the violation:

Remedy: Must obtain a color pallet approval.

Hedge installed on the City right of way needs approval and permits or to be removed.

Coral Gables has earned the title of "The City Beautiful" with the help of the residents. Your immediate cooperation in correcting the violation(s) listed above would be gratefully appreciated.

The Code Enforcement Division will re-inspect the property on **3/24/2021** to determine if corrective measures have been completed. If corrective measures have not been completed by **3/24/2021**, a Notice of Violation will be issued.

The Division is available for consultation on this matter from 7:30 AM to 4:00 PM. Please do not hesitate to call the Code Enforcement Officer below for additional assistance.

If this notice pertains to failure to maintain a historic structure, please be advised that:

- **You may be subject to substantial fines that may not be mitigated.**
- **You may also be required to repair or restore the historic structure.**
- **If the historic structure is allowed to deteriorate to the point where it must be demolished:**

- A
- **the City Code requires that you replace the structure with a similar historically-appropriate structure; and**
 - **the property will no longer qualify for an historic preservation tax exemption.**



 - o **La propiedad ya no será elegible para una exención de impuestos por preservación histórica.**
