Sole Source Justification	WPS USA CORP located at 7524 Standish Place, Suite 150, Rockville MD 20855 is the sole source authorized for the maintenance of all equipment in the city's Municipal Parking Garage 1, 2, 4 and 6. Therefore all parts are acquired through them and all service calls are performed by their trained technicians. The requested amount is to extend a Maintenance and Service Agreement in Parking Garage 2, 4 and 6 with WPS USA CORP for maintenance and service of the Parking and Revenue Control Equipment and consolidate the start and end dates of Parking Garage 1, 2, 4 and 6 maintenance agreements.  GARAGE 1 - 5 YEARS END IN 2022 (will not renew-Building willbe torned down Fall 2022)  GARAGE 2 AND 6-5 YEAR RENEWED EXTENSION ENDS IN 2023 (1 year extension \$50,400)  GARAGE 4 - 5 YEARS END IN 2024  Brief History  In 2015 City of Coral Gables purchased and installed a new parking and revenue control system (PARCS) for Garage 2 and Garage 6 from WPS Corp USA. In 2017, a new system was purchased and installed in Garage 1 and in 2018 a new system was purchased and installed in Garage 4. The PARCs system is used to manage traffic and transactions annually in the city's four public parking garages. At the end of each installation, the city entered into a five-year maintenance and service agreement with the vendor. The city is interested in combining the maintenance and service agreements for all four garages and extending the agreement with WPS through fiscal year 2024. The maintenance and service agreement with WPS will be in a form like the draft agreement attached that is mutually acceptable to the City Manager and City Attorney. That total cost of the maintenance and service agreement for Garage 2, 4 and 6 for 2023 will be Sixty-Four Thousand Seven Hundred Forty-Eight Dollars (\$64,748); for 2024 will be Sixty-Five Thousand Seven Hundred Forty-Eight Dollars (\$64,748); for 2024 will be Sixty-Five Thousand Seven Hundred Twenty-Six Dollars (\$65,726).

PARCs equipment installed in the City of Coral Gables Parking Garages must be serviced and maintained by WPS. Parts and service are for a proprietary Parking Access and Revenue Control System manufactured by WPS-Global, a Dynnic Company.

Be advised that WPS USA Corp. is the sole source for the purchase of the following equipment or components:

- 1. All WPS hardware and components including but not limited to:
  - a. Ticket Dispensers
  - b. Credit Card Exit Terminals
  - c. Pay on Foot and Pay in Lane cash & credit payment terminals
  - d. Credit Card only Pay on Foot terminals
  - e. PARCS Server and BC200 TRAC Software

  - g. All peripheral devices and components that comprise the total PARCS system
- 2. Hardware and software features
  - a. Aluminum terminal housings to minimize corrosion
  - b. Proprietary software code for secure processing of data
  - c. Custom developed universal communication board (MPB board) utilized in all terminals to communicate with BC200 TRAC Software
  - d. Unique intelligent barcode processing for on-line or off-line processing of revenue transactions
  - e. PCI compliant credit card processing software, proprietary to WPS USA Corp.

Concerning matching all garages to a January 1, 2022 start date, garages two and six, will be reset to start January 1, 2022. They are currently paid until 3/31/2022, and we will apply this as a credit when we restart their dates to January 1, 2022. This means that garages two and six for the year 2022 will require a payment amount of \$ 37,800.00 instead of 50,400.00.

Please note this is an addendum to the overarching contract, and all language and provision will remain in place.

#### **RESOLUTION NO. 2019-88**

A RESOLUTION OF THE CITY COMMISSION, AUTHORIZING THE CITY MANAGER TO ENTER INTO A FIVE-YEAR MAINTENANCE AND SERVICE AGREEMENT WITH WPS USA CORP TO PROVIDE MAINTENANCE AND SERVICE FOR THE PARKING AND REVENUE CONTROL EQUIPMENT IN CITY PARKING GARAGE 2 AND PARKING GARAGE 6.

**WHEREAS**, the City purchased and installed a new parking and revenue control system (PARCs) in Garage 2 and Garage 6 in 2014 from WPS; and

**WHEREAS**, the PARCs system is used to manage traffic and transactions in the City's four public parking garages; and

**WHEREAS**, the PARCs system manages more than 1,000,000 transactions annually in the City parking garages with a total value of nearly \$4,000,000; and

WHEREAS, the initial maintenance and service agreement is set to expire; and

WHEREAS, the City of Coral Gables is interested in continuing the maintenance and service arrangement with WPS for an additional five-year period;

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Manager is authorized to enter into a five-year maintenance and service agreement with WPS covering the PARCs equipment installed in Garage 2 and Garage 6 in a form substantially similar to the draft agreement attached that is mutually acceptable to the City Manager and City Attorney, and which reflects the intention of the Commission stated herein.
- **SECTION 3.** That this maintenance and service agreement will be in the total amount of Two-Hundred Forty-Four Thousand Eight-Hundred dollars (\$244,800.00).
- **SECTION 4.** That this Resolution should become effective upon the date of its passage and adoption herein.
