## **RESOLUTION NO. 2022-190**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE POLICE DEPARTMENT TO WAIVE THE COMPETITIVE BID PROCESS OF THE PROCUREMENT CODE PURSUANT TO SECTION 2-691 ENTITLED "SPECIAL PROCUREMENT/BID WAIVER" FOR THE LEASE OF ELEVEN (11) 2022 FLHP HARLEY-DAVIDSON MOTORCYCLES FROM PETERSON'S HARLEY-DAVIDSON OF MIAMI, LLC., FOR A THREE (3) YEAR PERIOD.

WHEREAS, the City's current lease for the 2020 Harley-Davidson FLHP motorcycles from Peterson's Harley-Davidson of Miami, LLC will expire on September 30, 2022; and

**WHEREAS**, Peterson's Harley-Davidson of Miami proposes a new lease agreement to replace the eleven (11) 2020 Harley-Davidson motorcycles for the Police Department's Special Enforcement Division/Motor Unit with new 2022 models; and

**WHEREAS**, the 2022 models cost \$740 per motorcycle, per month, for a three (3) year period in the amount of \$293,040.00 commencing upon the City's acceptance of delivery of the last new motorcycle under the new agreement; and

WHEREAS, Section 2-691 of the Procurement Code entitled "Special Procurement/Bid Waiver" authorizes a special procurement/bid waiver when an unusual or unique situation exists that makes the application of all requirements of competitive sealed bidding or competitive sealed proposal contrary to the public interest; and

**WHEREAS**, Section 2-585 of the Procurement Code entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards:

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the Police Department pursuant to Section 2-691 of the Procurement Code entitled "Special Procurement/Bid Waiver," for the lease eleven (11) 2022 Harley-Davidson FLHP motorcycles from Peterson's Harley-Davidson of Miami, LLC., for a three (3) year term with a total lease amount of \$293,040 for all leased motorcycles, subject to final approval and execution of a lease agreement by City staff.

**SECTION 3.** This Resolution shall become effective upon the date of its passage and adoption herein.
