On January 23, 2023, Officer Kristopher Clute and his trainee, Officer Juan Trujillo, responded to 10900 Old Cutler Rd reference a suspicious male on the sidewalk who was not dressed. The officers contacted the subject, who was mumbling unintelligibly. He advised he was in Cuba and he needed assistance because he wanted to hurt himself. The subject gave a name and date of birth, but he was unable to produce any type of identification. A record check revealed no record found for the information that was provided.


Officer Clute's knowledge and experience, with the totality of the circumstances of the call, he decided to take the extra step and contacted our CID unit to assist him identifying the subject. They utilized our new investigative tool, FACESNXT, which allows law enforcement officers to use photos of individuals to identify who they are. This effort successfully identified the subject with his correct name, which revealed he was a missing person since December 27, 2022, from 9674 NW 10 Av Lot 651 (23-000490). The subject was then transported to Larkin Hospital for further evaluation and a recovery of a missing person report was completed so his next of kin could be notified by the Miami-Dade Police Department (PD221227429900).

The next day, on January 24, 2023, Officer Clute was on patrol and he was following up with a complaint at 400 S Dixie Hwy (Chicken Kitchen) reference vehicles cutting through the parking lot from US1 to get to Lejeune Rd. Once he turned into the parking lot, Officer Clute observed two subjects conducting a hand-to-hand transaction of crack cocaine. Both offenders were detained and after Officer Clute completed his investigations, with the assistance from Officer Trujillo and CGPD SIS detectives, he recovered \$940.07 in small denominations and 13 bags of crack cocaine, which is consistent with street level narcotics sales. The same offender also had in his possession 15 Right Guard deodorant sticks in his backpack, which is consistent to items related to retail theft. Both offenders were arrested and transported to TGK. (23-000511)

Officer Kristopher Clute is one of the most experienced officers in the Uniform Patrol Division and he has always been thorough when doing his job. He has managed to training many of our officers within our agency and he has done so with pride, integrity, and dedication. In these two recent incidents he continues to set the example by using his intuition and located a missing person who needed assistance, then arrested two offenders who endangered the public with drug sales. Therefore, Officer Kristopher Clute should be recognized and awarded with the Officer of the Month for January 2023.



NARRATIVE

On January 23, 2023, at approximately 1011 hours, I was dispatched to 10900 Old Cutler Rd in reference to a suspicious male.

Upon arrival, I made contact with the suspicious male who identified himself as "Yalexey Jorge" who was sitting down without a shirt on and mumbling unintelligibly. Mr. Jorge advised that he was in Cuba and that he needed assistance as he wanted to hurt himself. He further stated that he does not take any medications but, has gone to Jackson Crisis on multiple occasions. Upon further investigation, the male could not produce any type of identification and seemed confused when asked about his first name. I then used facial recognition at which time it was determined that the male's correct name was "Idalexis Jorge". An FCIC/NCIC database check revealed that Mr. Jorge had been entered as a missing person on December 27, 2022 (reference Miami Dade Police case number PD221227429900) with his last seen location being 9674 NW 10 Av Lot 651.

Mr. Jorge was transported to Larkin hospital for further evaluation without incident (reference case number 23000488). CGPD Teletype Operator Isaac (ID 7762) notified Miami Dade Police Department of the missing person recovery.

Suspect Hate / Bias Motivated:

NARRATIVE

On Tuesday, 01/24/2023, while on patrol, this officer entered into the parking lot of 400 South Dixie Highway from Lejuene Road. I responded there as the owner of one of the establishments had complained of vehicles cutting through the parking lot from US1 to get to Lejuene Road.

As I turned into the parking lot, I observed a black male, Mr. Ronald Burke on one side of a bike, and a white male, Mr. Alexander Fonseca on the other side of the bike, with an open backpack being held by Mr. Burke. I observed Mr. Ronald Burke passing an unknown amount of clear baggies to Mr. Fonseca and then observed Mr. Fonseca place his hands inside his hoodie sweater. As I exited my vehicle, I witnessed Mr. Burke drop a plastic bag from his hands onto the floor. I then had Mr. Fonseca walk towards me as I told him to remove his hands from his sweater. I had him place his hands on my vehicle, as I watched Mr. Burke. There was also another black male, Mr. Melvin Mckenzie, that was sitting on a curb approximatley 15 feet away from where I originally witnessed Mr. Fonseca and Mr. Burke.

As my back up officers arrived, Officer J. Trujillo(#11684) patted down Mr. Fonseca for weapons and contraband. While conducting the pat down, Officer Trujilo confiscated four (4) clear baggies of suspected crack cocaine, which were located in the hoodie sweater on Mr. Fonseca. I then walked to where the original location was that I observed Mr. Burke drop a clear baggie, and I located a clear bag with eight (8) individually packaged suspected crack cocaine. I then observed one (1) bag of suspected crack cocaine on the floor, which came from Mr. Fonseca`s hoodie sweater as he walked towards me, and dropped, as I requested he take his hands out of his sweater.

Both Mr. Fonseca and Mr. Burke were placed under arrest and transported to CGPD for interviewing by CGPD SIS detectives V101 and V104. Both Mr. Burke and Mr. Fonseca were then transported to TGK. Mr. Mckenzie was released on scene. The thirteen (13) bags of suspected crack cocaine were tested and came back positive for cocaine. All property was impounded into CGPD property following Standard Operating Procedures and Rules and Regulations.

While conducting the investigation, the backpack that Mr. Burke was holding and owns, had 15 new Right Guard deoderant sticks. There was \$238 amount of cash on Mr. Burkes person, and \$702.07 amount of cash/cents in the backpack. The cash was in small denominations consistent with street level narcotics. The cash was impounded at CGPD property. Mr. Burke`s backpack and contents within were impounded at CGPD. Mr. Fonseca had a backpack and contents within which were also impounded at CGPD.

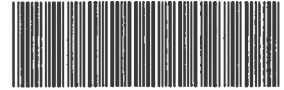
