RESOLUTION NO. 2025-271

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE CITY TO BE A TITLE SPONSOR OF THE MARK A. TROWBRIDGE CHAMBER FOUNDATION CENTENNIAL “GABLES-OPOLY” FUNDRAISING INITIATIVE.

WHEREAS, to celebrate the City’s Centennial, the Coral Gables Chamber of Commerce’s Mark A. Trowbridge Chamber Foundation is proposing a “Gables-Opoly” fundraising initiative; and

WHEREAS, the funds raised by the “Gables-Opoly” initiative will benefit the Mark A. Trowbridge Chamber Foundation, supporting programs in education, workforce development, and inclusive hiring; and

WHEREAS, the City Commission wishes for the City to be the title sponsor of the “Gables-Opoly” fundraising initiative;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City shall sponsor the Mark A. Trowbridge Chamber Foundation’s Centennial “Gables-Opoly” initiative as the title sponsor in the amount of Ten Thousand Dollars (\$10,000.00).

SECTION 3. That the City Commission does hereby approve the Ten Thousand Dollar (\$10,000.00) donation to the Mark A. Trowbridge Chamber Foundation for the Centennial “Gables-Opoly” title sponsorship.

SECTION 4. That the City will provide the Foundation with the appropriate City logos to be used in connection with the production and promotion of the “Gables-Opoly” initiative.

SECTION 5. That this Resolution shall become effective upon the date of its passage and adoption herein.




