RESOLUTION NO. 2025-278

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CULTURAL DEVELOPMENT BOARD TO APPOINT NELSON DE LEÓN, DR. JILL DEUPI, ADLER GUERRIER, SHERRY ZAMBRANO JACKSON, JACEK KOLASIŃSKI, MARK OSTERMAN, AND PERRI LEE ROBERTS TO THE ARTS ADVISORY PANEL TO SERVE FOR A TWO (2) YEAR TERM, WHICH BEGAN ON JUNE 1, 2025 AND CONTINUES THROUGH MAY 31, 2027.

WHEREAS, The Arts Advisory Panel is comprised of nine (9) members, with the Cultural Development Board recommending seven (7) member appointments to the City Commission; and

WHEREAS, On July 15, 2025 the Cultural Development Board voted to recommend re-appointment of eligible members of the Arts Advisory Panel; and

WHEREAS, On July 15, 2025 the Cultural Development Board voted to recommend appointment of three new members to the Arts Advisory Panel; and

WHEREAS, the following recommended appointees have agreed to serve: Nelson de León, Dr. Jill Deupi, Adler Guerrier, Sherry Zambrano Jackson, Jacek Kolasiński, Mark Osterman, and Perri Lee Roberts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this resolution upon adoption hereof.


SECTION 2. That the City Commission does hereby appoint Nelson de León, Dr. Jill Deupi, Adler Guerrier, Sherry Zambrano Jackson, Jacek Kolasiński, Mark Osterman, and Perri Lee Roberts as members of the Arts Advisory Panel for the remainder of a two (2) year term, which began on June 1, 2025, and continues through May 31, 2027.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.




