RESOLUTION NO. 2025-296

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF A KEEP AMERICA BEAUTIFUL COCA-COLA GREATEST AMERICAN CLEANUP ACTIVATION GRANT AGREEMENT IN THE AMOUNT OF \$2,000 TO SUPPORT THE KEEP CORAL GABLES BEAUTIFUL, CLEANUP WITH PUPS + ADOPTIONS EVENT; AUTHORIZING THE EXECUTION OF THE GRANT AGREEMENT; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2024-2025 ANNUAL BUDGET TO RECOGNIZE THE FUNDS AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO PUT TOWARDS THE COST OF THE PROGRAM.

WHEREAS, the City of Coral Gables has been awarded a \$2,000 Keep America Beautiful Coca-Cola Greatest American Cleanup Activation Grant to support the Keep Coral Gables Beautiful (KCGB) Cleanup with Pups + Adoption Event; and

WHEREAS, the event will take place on October 4th, 2025, will pair volunteers with dogs available for adoption with the Miami-Dade County Animal Services to take the dogs on litter walks through William H. Kerdyk, Jr., and Family Park and the surrounding neighborhood; and

WHEREAS, this event supports community engagement, promotes pet adoption, and contributes to the City's environmental and beautification goals; and

WHEREAS, the City Manager is authorized to execute this amendment, as well as any future amendments to this agreement;

NOW, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the forgoing **"WHEREAS"** clauses are hereby confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption herein.

SECTION 2. That the City Commission does hereby authorizes the acceptance of the Coca- Cola Greatest American Cleanup Activation Grant in the amount of \$2,000 towards the Keep Coral Gables Beautiful program.


SECTION 3. That the City Commission does hereby authorizes the City Manager to execute the grant agreement with Keep America Beautiful.
