RESOLUTION NO. 2025-304

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE POLICE DEPARTMENT TO ENTER INTO A LEASE AGREEMENT OF THREE (3) YEARS FOR ELEVEN (11) 2025 FLHP HARLEY-DAVIDSON MOTORCYCLES FOR AN ESTIMATED AMOUNT OF \$346,500.00 AS A “SOLE SOURCE” PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE.

WHEREAS, the City’s current lease for the 2022 Harley-Davidson FLHP motorcycles from Peterson’s Harley-Davidson of Miami, LLC will expire on October 30, 2025; and

WHEREAS, Peterson’s Harley-Davidson of Miami proposes a new lease agreement to replace the eleven (11) 2022 Harley-Davidson motorcycles for the Police Department’s Special Enforcement Division/Motor Unit with new 2025 models; and

WHEREAS, the 2025 models cost \$875 per motorcycle per month, for a three (3) year period in the amount of \$346,500.00 commencing upon the City’s acceptance of delivery of the last new motorcycle under the new agreement; and

WHEREAS, Section 2-689 A contract may be awarded without competitive bids or proposals when the Procurement Officer, after conducting a good faith review of all available sources, determines in writing, pursuant to a written request from a department head, that the contract by its very nature is not suitable to competitive bids or proposals, as there is only one source for the required supply, service or construction item capable of fulfilling the needs of the city; and

WHEREAS, Section 2-585 of the Procurement Code entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission hereby accepts the recommendation of the Police Department pursuant to Section 2-689 of the Procurement Code entitled “Sole Source” for the lease of eleven (11) 2025 Harley-Davidson FLHP motorcycles from Peterson’s Harley-Davidson of Miami, LLC., for a three (3) year term with a estimated amount of \$346,500.00 for all leased motorcycles, subject to final approval and execution of a lease agreement by City staff.

SECTION 3. This Resolution shall become effective upon the date of its passage and adoption herein.




