RESOLUTION NO. 2025-315

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF AMENDMENT NO. 1 TO GRANT AGREEMENT NO. LPA0498 WITH THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP) IN THE AMOUNT OF \$700,000; APPROVING THE EXTENSION OF THE EXPIRATION DATE FOR THE CORAL GABLES FORCE MAIN REPLACEMENT PROGRAM FROM NOVEMBER 30, 2025, TO NOVEMBER 30, 2026; AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AMENDMENT TO THE AGREEMENT WITH FDEP FOR SAID FINANCIAL ASSISTANCE.

WHEREAS, the City was awarded a Florida Department of Environmental Protection (FDEP) Grant for a Force Main Replacement Program in the amount of \$ 700,000; and

WHEREAS, the City requested extension to this agreement of the performance period; and

WHEREAS, an amendment to the agreement has no negative impact to the City's grant award with FDEP; and

WHEREAS, The City Manager is authorized to execute this amendment, as well as any future amendments to this agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. That the City Commission does hereby authorizes the execution of grant agreement no. LPA0498 amendment 1.

SECTION 3. That the City Manager is hereby authorized to execute this amendment, as well as any future amendments to this agreement.

SECTION 4. That this Resolution shall become effective upon the date of its adoption herein.


