DRAFT RESOLUTION _____

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND THE ARCHITECTURAL CONSULTANT SERVICES CONTINUING CONTRACTS WITH STANTEC CONSULTING, INC., AECOM TECHNICAL SERVICES, INC., FERGUSON GLASGOW SCHUSTER SOTO, INC. (FGSS), AND MC HARRY & ASSOCIATES, INC. PURSUANT TO SECTION 2-829 OF THE PROCUREMENT CODE ENTITLED “APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS”, UNTIL JUNE 30, 2016, UNTIL SUCH TIME AS THE NEGOTIATIONS ARE COMPLETED AND NEW CONTRACTS ARE EXECUTED PURSUANT TO THE CURRENT RFQ PROCESS.

WHEREAS, on December 7, 2011, the City Commission approved continuing contracts for Architectural consulting services as the result of a Request for Qualifications (RFQ) process; and

WHEREAS, the purpose of the continuing contracts are to provide architectural & engineering design services including structural, electrical, mechanical, plumbing, fire protection, and landscaping design; and

WHEREAS, the current contracts Stantec Consulting, Inc., AECOM Technical Services, Inc., Ferguson Glasgow Schuster Soto, Inc. (FGSS), and MC Harry & Associates, Inc. expired on December 7, 2015; and

WHEREAS, in order to allow time to finalize the negotiations of the Professional Service Agreements, and for new contracts to be completed, approved, and executed, and to process extensions of the existing continuing contracts, it is recommended that the Architectural Consulting Services contracts be extended until June 30, 2016; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contract; and

WHEREAS, the contracts with Stantec Consulting, Inc., AECOM Technical Services, Inc., Ferguson Glasgow Schuster Soto, Inc. (FGSS), and MC Harry & Associates, Inc. may be extended under Section 2-829 of the Procurement Code entitled “Approval of Change Orders and Contract Modifications”.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accept the recommendation of the Chief Procurement Officer to extend the Architectural Consulting Services continuing contracts with Stantec Consulting, Inc., AECOM Technical Services, Inc., Ferguson Glasgow Schuster Soto, Inc. (FGSS), and MC Harry & Associates, Inc. , pursuant to Section 2-829 of the Procurement Code entitled “Approval of Change Orders and Contract Modifications”, until June 30, 2016, until such time as the negotiations are completed, and new contracts are executed pursuant to the current RFQ process.

Section 3. That the City Commission does hereby authorize the City Manager to execute an extension of the Contract with such modifications to the form attached hereto as Exhibit “A” as may be approved by the City Manager and City Attorney that are necessary to implement the intent of this Resolution.

Section 4. That this Resolution shall become effective upon the date of its adoption herein.
