#### Police Update:

## • Update on traffic accidents in Coral Gables

- o Sgt. Lopez informed the Board of 4 fatal accidents this year to date. A possible 5<sup>th</sup> accident that is still under investigation. Debbie asked, aside from fatalities, how many accidents have been reported. Sgt. Lopez advised that 749 accidents had been reported so far. The Board asked about the number of accidents in previous years. Sgt. Lopez provided the information.
- o The Board asked if the Valets on Ponce de Leon, 37<sup>th</sup> and Lejeune can be eliminated. Staff advised they would need to confer with the Parking Department.
- o Sgt. Lopez updated the Board on the Pedestrian Bicycle Grant. The grant is for an educational program which provides about 16k for educational material for pedestrians and bicyclists.
- Vice Mayor Rhonda Anderson spoke to the Board regarding the Vision Zero Resolution. Henry spoke about the resolution the TAB proposed to move an item on the agenda to openly discuss it now. Henry updated the Board that he was supposed to go before the commission to present the resolution from TAB to have developers come and better explain the traffic impact studies and potential changes for micro mobility for egress in and out of the property and all those parameters. Henry stated that per commissioner Fernandez suggestion to withdraw that resolution and resubmit with more specific parameters of how TAB want it, suggesting a new resolution tasking the commission to task the TAB to come up with what makes sense for TAB to in Traffic Impact Studies.

The Board discussed traffic impact studies. Silvia asked about the form that is given to developers. Stating that everyone has their own form, and it doesn't contain pedestrian studies. Staff clarified that it is not a form. Staff advised of the process. The developer and staff have a scoping meeting. At this scooping meeting staff has an agenda (that has been shared with TAB before) that goes over everything that could be included in the traffic impact study depending on the type of development. Traffic impact studies are going to be different because all developments are different. Henry would like to create a traffic impact study for the layperson that would include pedestrian and the impact a building has in terms of transportation and quality of life. Staff clarified that a traffic impact study is a data driven study, it doesn't measure resident happiness, the development review process is what looks at the impact to the community.
