A Resolution accepting the recommendation of the Procurement Officer pursuant to Section 2-501 of the Procurement Code to waive the Procurement Code and authorize the City Manager to enter into a professional services agreement for Jobs 4 Blue (Off-Duty Job Scheduling) services with Visual Computer Solutions (VCS).

Mayor Valdes-Fauli: A Resolution accepting the recommendation of the Procurement Officer.

City Attorney Ramos: Pursuant to Section 2-501 of the Procurement Code to waive the Procurement Code and authorize the City Manager to enter into a Professional Services Agreement for Jobs 4 Blue, off duty scheduling services with Visual Computer Solutions (VCS).

Procurement Officer Walker: Good afternoon, Celeste Walker, Assistant Finance Director for Procurement. We are asking for the approval of a waiver to utilize the software for Jobs 4 Blue. This particular software is going to be utilized by the Police Department to facilitate the off-duty scheduling. This particular service is currently being utilized through a system that was

implemented by our Information Technology Department and currently being managed by them. We want to merge over to a new system that is currently being managed by POS, which is our Police Officers Scheduling software and there is a module that we currently have access and own. There will be no additional cost to utilize this particular function; and in addition to that the City also will be retaining administrative fees for the services.

Mayor Valdes-Fauli: Alright.
