## B.-1. 24-8504 AiPP Waiver Request: 4241 Aurora - Jaume Plensa

Panel members were advised of the 4241 Aurora Ave. development project's request for a waiver of paying the Art in Public Places (AiPP) fee in lieu of purchasing and installing public art on the project site to be deeded to the city. Materials were provided about the proposed artist and artwork.

Members of the 4241 Aurora Ave. development team addressed the Panel, along with the artist's studio representative, and presented information about proposed artist Juame Plensa, and the proposed artwork "Minna." Details were provided about the material, dimensions, siting, maintenance, and cost. The development team advised the Panel that the site plan had been developed in response to staff and community input.

The proposed artwork was enthusiastically embraced with members requesting clarification on whether the piece is unique or part of an edition. Carlos Duran, representing the artist's studio, stated that the work is currently a unique piece; however, it is undecided whether further castings will be made. If so, he said, there would be no more than five in the series. Mr. Duran noted that the work is the last in the artist's portrait series.

Members discussed the material, maintenance, and discussed concerns about the proposed location. It was mentioned that the public would benefit from experiencing how the form changes while walking around the sculpture. All agreed that paving around the piece would accomplish this and keep irrigation and landscaping maintenance from adversely affecting the artwork.

Members also noted the importance of placing the artwork away from any tree canopy to retain the vibrancy of the piece and avoid falling plant debris.

The developer's representative responded that paving around the piece is possible and that the location of canopy trees would be addressed through the city's landscape team.

With no further discussion, the following motion was made.
