RESOLUTION NO. 2025-

A RESOLUTION OF THE CITY COMMISSION, ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF THE RESULT OF THE CITY OF CORAL GABLES GENERAL BIENNIAL ELECTION, WHICH WAS HELD ON APRIL 8, 2025, WHEREIN VOTERS RE-ELECTED VINCE LAGO TO HOLD OFFICE AS MAYOR GROUP I, FOR A TERM OF TWO YEARS; SAID TERM TO BEGIN AT NOON ON THE THIRD FRIDAY AFTER THE ELECTION, UNTIL NOON ON THE THIRD FRIDAY AFTER THE GENERAL BIENNIAL ELECTIONS SCHEDULED FOR APRIL 13, 2027.

WHEREAS, on April 22, 2025, following the closure of the polls at 7 p.m., in connection with the City of Coral Gables General Biennial Election, the Miami-Dade Elections Department counted the votes cast for those candidates who sought to hold office for Mayor (Group 1); and

WHEREAS, the tabulation of vote count of the total ballots cast yielded the following results:

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby accept the City Clerk's Certification and Declaration of the Result from the Coral Gables General Biennial Election (2025), and made a part of this Resolution, in connection with the election of Vince Lago, to the position of City Mayor, Group 1, for a two-year term to begin at noon on the third day after the election, until noon on the third day after the General Biennial Election scheduled for April 13, 2027.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
