**CITY COMMISSION MEETING**  
November 8, 2017

**ITEM TITLE:**

An Ordinance adopting and enacting a new Code for the City of Coral Gables, Florida; providing for the repeal of certain Ordinances not included therein; providing a penalty for the violation thereof; providing for the manner of amending such Code; and providing when such Code and this Ordinance shall become effective.

**RECOMMENDATION OF THE CITY ATTORNEY/CITY CLERK:**

That the republication of the Code of the City of Coral Gables, Florida of 1991, including all general and permanent Ordinances adopted through Ordinance No. 2005-25, adopted September 13, 2005 and Ordinance No. 2006-07, adopted April 18, 2006. The new republication includes ordinances adopted from April 18, 2006 through January 10, 2017.

**BRIEF HISTORY :**

On April 18, 2006, the City Commission of Coral Gables passed and adopted Ordinance No. 2006-07, thus enacting a new Code for the City; further providing for the repeal of certain Ordinances not included therein; providing penalty for violation thereof; providing for manner of amending such code; thereby declaring an emergency measure for the purpose of waiving the thirty-day waiting period.

The source materials used in the preparation of the new code were the 2006 Code and Ordinances adopted by the City Commission. The source of each section is included in the history note appearing in the parentheses at the end thereof. The absence of such a note indicates that the section is new and was adopted for the first time with the adoption of the Code. By the use of comparative tables appearing in the back of the new Code, one may locate any Section of the 2006 Code, as supplemented, and any subsequent Ordinance included herein.

On April 25, 1991, the City Commission of Coral Gables, passed and adopted Ordinance No. 2935, thus enacting a new Code for the City; further providing for the repeal of certain Ordinances not included therein; providing penalty for violation thereof; providing for manner of amending such code; thereby declaring an emergency measure for the purpose of waiving the thirty-day waiting period.
