RESOLUTION NO. 2026-76

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA URGING MIAMI-DADE COUNTY TO AMEND SECTION 31-107 “VEHICLE STANDARDS” OF THE MIAMI-DADE COUNTY CODE TO ALLOW FOR USE OF CERTAIN PASSENGER MOTOR CARRIER VEHICLES FOR UP TO TWENTY MODEL YEARS OF AGE, OR 350,000 MILES OF USAGE.

WHEREAS, Miami-Dade County Code prescribes vehicle standards for passenger motor carriers operating in Miami-Dade County, including the City’s trolley system; and

WHEREAS, currently, the County Code provides that passenger motor carrier vehicles providing circulator or fixed route service shall not be placed into service or operate if the vehicle is over fifteen (15) model years of age; and

WHEREAS, the City of Coral Gables has reviewed these requirements, and given improvements in technology and infrastructure, believes that the County should change this requirement to allow passenger motor carrier vehicles providing circulator or fixed route services to operate for up to twenty (20) model years of age or 350,000 miles of usage, whichever comes first;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission urges the Miami-Dade County Board of County Commissioners to adopt legislation amending Section 31-107 “Vehicle Standards” of the Miami-Dade County Code to allow for operation of passenger motor carrier vehicles providing circulator or fixed route services to operate for up to twenty (20) model years of age or 350,000 miles of usage, whichever comes first.

SECTION 3. That a copy of this Resolution be sent to all members of the Miami-Dade County Board of County Commissioners and the County Mayor.


SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
