RESOLUTION NO. 2010-267

RESOLUTION AUTHORIZING EXPENDITURES IN THE AMOUNT OF \$150,000.00 IN STATE FORFEITED ASSET FUND (FAF) MONIES TO REIMBURSE THE CITY OF CORAL GABLES GENERAL FUND FOR EXPENDITURES ASSOCIATED WITH THE POLICE COMMUNICATIONS CENTER PROJECT.

WHEREAS, the Coral Gables Police Department's investigations of criminal activity produce forfeited funds, both related and unrelated to its participation in the South Florida Money Laundering Strike Force operations; and

WHEREAS, the Coral Gables Police Department may lawfully retain at the conclusion of the legal proceedings the forfeited funds as authorized under Florida State Statute 932.7055; and

WHEREAS, the 2010 Florida House of Representatives General Appropriations Act (HB 5003) Section 8 provides that "for the 2010-2011 Fiscal Year the funds in a special law enforcement trust fund established by the governing body of a municipality may be expended to reimburse the general fund of the municipality for monies advanced from the general fund to the special law enforcement trust fund prior to October 1, 2001"; and

WHEREAS, the Coral Gables Interim Police Chief, Joseph McNichol, and the Coral Gables Finance Director, Donald G. Nelson, attest having deposited the sum of \$150,000.00 in said forfeited funds into the Coral Gables Forfeited Asset Fund; and

WHEREAS, the FAF Committee met on December 6th, 2010 and followed the FAF Committee operating procedures adopted on July 23, 2002; and

WHEREAS, The FAF Committee approved the Coral Gables Interim Police Chief's request to expend the available funds on the specific items listed below on this resolution; and

WHEREAS, the 2010-2011 Annual Budget is hereby amended to increase the estimated revenues by \$150,000.00 and to increase the general fund reserve by \$150,000.00;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby direct the City Manager to authorize the Finance Director to expend \$150,000.00 from State Forfeited Asset Fund monies to reimburse the City

of Coral Gables general fund for expenditures associated with the Police Communications Center Project as provided for by the Florida Legislature and Florida State Statute 932.7055.

SECTION 3. That the 2010-2011 Annual Budget is hereby amended to increase the estimated revenues by \$150,000.00 and to increase the general fund reserve by \$150,000.00.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.




