REQUEST FOR PERMISSION TO ENCROACH

Dear Sirs;

We act for Giralda PB, LLC, a Florida Limited Liability Company, ('Giralda') the Applicant. Giralda is presently renovating its property at 2222 Ponce de Leon Blvd. (see attached legal description) and in connection therewith the issue of maintaining the use of an existing soakage pit (existing since +/- 1972) located within Giralda Avenue has arisen.

As a result, and notwithstanding our request, originally approved by the Department of Public Works, to be, in effect, "grandfathered" by virtue of the existing soakage pit; the Department now advises that a Public Hearing is required before the City Commission.

Therefore; we have attached hereto and incorporated herein all of the requisite drawings and plans necessary to support this request "to encroach into and under the public right of way"; namely Giralda Avenue in front of the 2222 Ponce building and have located thereupon the exact location of the existing soakage pit to which we request permission to maintain the use of.

Please be advised by way of explanation as to why there is no space to install any on-site drainage that the approved site plan currently contains a building with a depressed sitting area. This approved site plan replaces the depressed sitting area with a new addition and therefore leaves no room to install on-site drainage; hence the need to maintain the existing use of the off-site soakage pit for drainage.

In connection with this request, the Applicant understands and agrees that a Restrictive Covenant Running with the Land shall be required should the City Commission agree to and thereupon approve this request. The minimum conditions usual and customary to the granting of such requests as herein described are acceptable to the Applicant and shall be included in the required Covenant.

A filing fee of \$300.00 is included herewith.
