





BOARD OF ADJUSTMENT NOTICE OF PUBLIC HEARING

All interested parties are hereby notified that the Board of Adjustment of the City of Coral Gables, Florida will hold a public hearing for the purpose of hearing variance requests and taking action on such requests, reviewing and taking action on appeals from Administrative Officials, and other decision-making orders, as outlined in Section 2-401 of Ordinance No. 1525, as amended and known as the "Zoning Code" of the City of Coral Gables, Florida, to wit:

1. Case No. 8682-Z Consider a variance request in regard to the proposed new detached canopy for the existing property located at 90 Merlores Avenue, Coral Gables, Florida, also known as Phillips Park.
2. Case No. 8683-Z Consider a variance request in regard to proposed shelter canopy for the existing property located at 25 Sunrise Avenue, Coral Gables, Florida, also known as Sunrise Harbor Park.
3. Case No. 8685-Z Consider a variance request in regard to the existing generator encroaching into the required side setback area.

Interested parties may express their views at the hearing or file them in writing with the undersigned on or before the commencement of the hearing which will be held before the Board of Adjustment of the City of Coral Gables at City Hall, 405 Biltmore Way, in the Commission Chamber, Coral Gables, Florida, commencing at 8:00 A.M., Monday, October 6, 2008.

If a person decides to appeal any decision made by a board / committee with respect to any matter considered at a meeting or hearing, that person will need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
