RESOLUTION NO. 2025-23

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF INNOVATION AND TECHNOLOGY OFFICER AUTHORIZING AN ENTERPRISE LICENSE AGREEMENT WITH QUANTELA, INC., FOR THE RENEWAL OF THE QUANTELA URBAN ANALYTICS PLATFORM PURSUANT TO SECTION 2-689, SOLE SOURCE PROCUREMENT OF THE PROCUREMENT CODE.

WHEREAS, the City of Coral Gables, through the Systems Division, in the Innovation and Technology (IT) department, has previously engaged with QUANTELA, INC. for Quantela Urban analytics for its Citizen Services and IoT data collection for over years; and

WHEREAS, the dashboards, data and derivative charts and displays produced by QUANTELA, INC. have served the City's decision-making processes and presentation needs; and these processes and presentations support important City operations; and

WHEREAS, the City of Coral Gables desires to continue with the advanced capability now provided through cloud services, and other enhanced citizen services and features for enterprise applications, crime analysis, sustainability management, facilities management, public notice, smart devices, mobile services, data analytics, and cloud computing; and

WHEREAS, QUANTELA, INC. is the sole-source provider of Quantela Platform; and

WHEREAS, a renewal with QUANTELA, INC. offers significant cost avoidance over piecemeal license acquisition; and

WHEREAS, the IT department has the need to renew the annual maintenance of the Quantela at reserved pricing for a period of five (5) years at \$61,973 plus inflation; and

WHEREAS, the Procurement Officer has determined that QUANTELA, INC. is the sole source provider of Quantela Urban analytics platform and services under Section 2-689 of the Procurement Code; and

WHEREAS, Section 2-650 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation to authorize renewal with QUANTELA,INC., for the purchase of on-going City-wide access and unlimited use of the Quantela Urban Analytics platform, products and services as long as the services are required in an amount not to exceed the available budget pursuant to Section 2-689, Sole Source Procurement, of the Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.




