RESOLUTION NO. 2025-164

A RESOLUTION OF THE CITY COMMISSION DIRECTING CITY STAFF TO DEVELOP AND IMPLEMENT A PLAN FOR INCREASED TRAFFIC ENFORCEMENT IN THE VICINITY OF CORAL GABLES HIGH SCHOOL AT CERTAIN TIMES AND DIRECTING CITY STAFF TO WORK WITH OUTSIDE AGENCIES AND RESOURCES AS NEEDED.

WHEREAS, the area surrounding Coral Gables High School experiences increased vehicular and pedestrian traffic around school start time and dismissal; and

WHEREAS, the safety of students, staff, residents, and other road users in the vicinity of Coral Gables High School is a matter of utmost importance to the City; and

WHEREAS, increased traffic enforcement by the City's Police Department has proven effective in ensuring compliance with traffic laws; and

WHEREAS, the City Commission desires that City Staff prioritize traffic enforcement efforts in the vicinity of Coral Gables High School during school start time and dismissal;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That City Staff is directed to develop and implement plans for increased traffic enforcement in the areas surrounding Coral Gables High School on school days around school start time and dismissal.
- **SECTION 3**. That the plans should include strict enforcement of laws governing vehicle operation and actively encouraging safer pedestrian behavior, including the use of sidewalks and crosswalks.
- **SECTION 4.** That City Staff will work with outside agencies and resources as needed.
- **SECTION 5.** That this Resolution shall become effective upon the date of its adoption herein.
