## DRAFT RESOLUTION NO. 2017-

A RESOLUTION AMENDING ORDINANCE 2015-17, AS AMENDED, TO ADJUST THE FEES FOR SPECIAL EVENTS AND INCREASE NON-RESIDENT ADMISSION FEES FOR VENETIAN POOL.

WHEREAS, Ordinance 2015-17 passed and adopted by the City Commission on June 16, 2015 and subsequently amended by Resolution 2016-75, as permitted by the Ordinance, established fees for various licenses, permits, services and penalties by the City of Coral Gables; and

WHEREAS, the Special Events Permit Fees will be revised by changing the type of fees to reflect the new special event guidelines. The new fees will be based on event type to fees based on event attendance, amount of event days, and statusof event organizer.

WHEREAS, by reducing the Venetian Pool capacity from 600 to 450 general admission, the loss in revenue with a reduction in daily visitors can be mitigated recovered by the increase in non-resident fees.

WHEREAS, non-resident adult fee (13 & above) will increase by \$2 from \$13 to \$15 per person and a new peak season fee with an increase of \$7.00 from the original admission fee will be assessed between Memorial Day and Labor Day weekend with an admission fee of \$20 per non-resident adult.

WHEREAS, non-resident child (ages 3-12) will increase by \$2 from \$8 to \$10 per person and a new peak season fee will be assessed between Memorial Day and Labor Day weekend with an admission fee of \$15 per non-resident child.

WHEREAS, birthday party supplemental admission packs will increase to reflect the increase in non-resident admission fees. Neither resident nor field trip/camp fees will be affected by this increase.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The City Commission revises the Fee Schedule as follows:
