**SECTION 2.** That the City Commission does hereby authorize free parking for participants in Parking Garage Four (4) and a waiver for the cost of \$590.00 for fifty-nine (59) parking meter rentals on Biltmore Way adjacent to City Hall for the "**Coral Gables Walk MS,**" scheduled for April 16, 2016; and




