

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2009-340**

A RESOLUTION AMENDING THE FISCAL YEAR 2008-2009 ANNUAL BUDGET AND AUTHORIZING A TRANSFER OF FUNDS FROM THE STORMWATER UTILITY FUND AND THE SANITARY SEWER SYSTEM FUND INTO THE GENERAL FUND FOR INDIRECT OPERATING COSTS PROVIDED BY THE GENERAL FUND DEPARTMENTS FOR THE FISCAL YEAR ENDED SEPTEMBER 30, 2009.

**WHEREAS**, the General Fund departments provided indirect operating costs in the estimated amount of \$120,000 to the Stormwater Utility Fund during Fiscal Year 2008-2009; and

**WHEREAS**, the General Fund departments provided indirect operating costs in the estimate amount of \$615,000 to the Sanitary Sewer System Fund during Fiscal Year 2008-2009; and

**WHEREAS**, the transfer of funds from the Stormwater Utility Fund and from the Sanitary Sewer System Fund is to cover the estimated indirect operating costs provided by the City's General Fund for the Fiscal Year ended September 30, 2009;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby amend the Fiscal Year 2008-2009 Annual Budget and authorizes the Finance Director to transfer the aforementioned funds in the amount of \$120,000.00 from the Stormwater Utility Fund and the amount of \$615,000.00 from the Sanitary Sewer System Fund into the General Fund for the Fiscal Year ended September 30, 2009.

**SECTION 3.** That this Resolution shall become effective immediately upon the date of its passage and adoption herein.


