**RESOLUTION NO. 2021-277**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION CHIEF PROCUREMENT OFFICER TO EXTEND THE EXISTING CONTRACT PURSUANT TO SECTION 2-764(B), APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS OF THE PROCUREMENT CODE FOR BROKER SERVICES PROVIDED BY THE COMPREHENSIVE COMPANIES FOR ADMINISTRATION OF VOLUNTARY SUPPLEMENTAL EMPLOYEE INSURANCE BENEFITS.

**WHEREAS**, on July 1, 2020 the City entered into a Professional Services Agreement with The Comprehensive Companies to establish a contract for the administration of citywide voluntary supplemental insurance employee benefits; and

**WHEREAS**, The Comprehensive Companies offers the City's voluntary benefits directly to City employees through individual payroll deduction, and

**WHEREAS**, these supplemental voluntary employee insurance benefits include; short-term disability, long-term disability, critical illness, accident insurance, hospitalization insurance and other supplemental voluntary insurance benefits; and

**WHEREAS**, The Comprehensive Companies shall not be compensated by the City as these voluntary employee benefits programs are offered through a payroll deduction at the employee's expense and the City does not subsidize any portion of the cost; and

**WHEREAS**, the City is solely responsible for collecting the employee paid deductions and transferring these funds to The Comprehensive Companies as payment for the selected benefits; and

**WHEREAS**, the City desires to continue to allow employees access to the current benefits and pricing offered by the Comprehensive Companies without interruption by extending the current Professional Services Agreement for brokerage services through December 31, 2022; and

**WHEREAS**, the City finds that utilizing the existing contract is in the City's best interest and will allow the City to maintain the pricing structure currently in place;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The City Commission accepts the recommendation of the Chief Procurement Officer to extend the existing professional service agreement until December 31, 2022 or until a new solution is in place to facilitate the benefits, pursuant to Section 2-764(b) of the Procurement Code entitled “Approval of Change Orders and Contract Modifications”.


**SECTION. 3** That the City Commission finds that doing so is in the best interests of the City.

**SECTION 4.** That this Resolution shall become effective upon the date of its adoption herein.
