RESOLUTION NO. 2023-166

A RESOLUTION OF THE CITY COMMISSION APPROVING THE PETITION LANGUAGE FOR AN AMENDMENT TO COCOPLUM PHASE 1 ROVING PATROL SPECIAL TAXING DISTRICT TO EXPAND THE SCOPE OF SERVICES TO INCLUDE ADDITIONAL SECURITY MEASURES INCLUDING BUT NOT LIMITED TO SECURITY CAMERAS.

WHEREAS, on May 24, 2023, Coral Gables residents met with City Staff to discuss the possibility of expanding the security services within the Cocoplum Phase 1 Security Guard Special Taxing District; and

WHEREAS, on June 8, 2023, the City of Coral Gables received a letter of intent from over 20% of the homeowners within the Cocoplum Phase 1 Security Guard Special Taxing District (“Cocoplum”) requesting a modification to the Cocoplum Phase 1 Security Guard Special Taxing District Cocoplum to expand the scope of services to include additional security measures including but not limited to security cameras; and

WHEREAS, City staff has reviewed this request and in accordance with the Special Taxing District Amendment process, as adopted the City of Coral Gables Commission as the governing body of Cocoplum, a petition was created to be circulated to all the properties located within the boundaries of Cocoplum; and

WHEREAS, in accordance with the Special Taxing District Amendment process once the petition has been created it must be brought before the City of Coral Gables Commission for approval prior to distribution to the petitioners; and

WHEREAS, the City of Coral Gables Commission has reviewed the petition and believes that it provides sufficient information for all residents of Cocoplum to make an informed decision and therefore wishes to approve the petition as presented for modifications to Cocoplum;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:




