The Citizens' Independent Transportation Trust is the oversight board created by Miami-Dade County voters to monitor the implementation of the People's Transportation Plan (PTP) and the use of the proceeds of the ½-percent transit surtax. Responsibilities include providing support to the 15-member volunteer Board, recommending administrative policies for the monitoring of surtax-funded projects and overseeing more than \$200 million in annual surtax funds collected and allocated according to the PTP. Notable accomplishments to date are securing the CITT Financial Consultant, supervising final approval of the PTP Amendment by the Board of County Commissioners (BCC), streamlining the CITT Committee process, as well as establishing an Office Policy and Procedures Manual and revising existing Travel guidelines.
