RESOLUTION NO. 2021-348

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING A CONTRACT MODIFICATION TO THE FOUNTAIN MAINTENANCE CITYWIDE SERVICE CONTRACT IFB 2019-001, WITH OLIVER'S POOLS, INC. PURSUANT TO SECTION 2-764 (B), APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS, OF THE CITY'S PROCUREMENT CODE IN AN ANNUAL ESTIMATED AMOUNT OF \$182,000 FOR ADDITIONAL FOUNTAIN MAINTENANCE SERVICES TO BE PERFORMED.

WHEREAS, on March 12, 2019, the City awarded the agreement for fountain maintenance and repair services through all City fountains; and

WHEREAS, the existing contract capacity is currently \$55,200, per year, which only covers routine cleaning; and

WHEREAS, the additional amount requested will allow for troubleshooting and correcting problems in fountain systems, pre-maintenance, maintenance repair, emergency repair, and other fountain related work; and

WHEREAS, this initial increase will cover \$182,000 in additional expenses to the contract in the amount of \$55,200 during fiscal year 2021-2022 as well as each year moving forward based on need and will not exceed the available budget.; and

WHEREAS, Public Works is seeking approval for the additional spending authority in order to continue to maintain City fountains;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission approved the contract modification in the amount of \$182,000 for the duration of the contract, not exceed the available budget for additional work performed under the contract, pursuant to Section 2-764(b) of the City's Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
