Exclusive franchise to provide Solid Waste Collection to Multi-Family and Commercial properties within the City of Coral Gables.

Current Agreement between City of Coral Gales and Waste Management Inc. of Florida (WM)

Term

- Initial Term January 1, 2011 September 30, 2018 (Resolution 2010-278)
- 2-year Option to Renew exercised October 1, 2018 September 30, 2020
