RESOLUTION NO. 2023-21

A RESOLUTION OF THE CITY COMMISSION ACCEPTING A PROPOSAL FROM ARTIST JANINE ANTONI AND APPROV-ING THE FABRICATION AND INSTALLATION OF THE SCULPTURE WHISPERING THROUGH A STONE, (UNANI-MOUSLY RECOMMENDED BY THE ARTS ADVISORY PANEL, APPROVAL/DENIAL VOTE: 7 TO 0, AND THE CUL-TURAL DEVELOPMENT BOARD APPROVAL/DENIAL VOTE: 7 TO 0); AUTHORIZING THE CITY MANAGER OR HIS OR HER DESIGNEE TO NEGOTIATE AN AGREEMENT WITH THE ARTIST; AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2022-2023 AMENDED BUDGET TO RECOGNIZE AS REVENUE A TRANSFER FROM THE ART IN PUBLIC PLACES RESERVE. AND APPROPRIATING SUCH FUNDS TO PUT TOWARD THE COST OF FABRICA-TION, INSTALLATION, AND RELATED EXPENSES RE-GARDING THE ARTWORK.

WHEREAS, the City Commission has consistently expressed interest in building the City's permanent public art collection with artworks by prominent artists representing a diversity of background and disciplines; and

WHEREAS, on August 2, 2022, the Arts Advisory panel reviewed a proposal including *Whispering Through a Stone* by Janine Antoni and recommended approval of the proposal for permanent installation; and

WHEREAS, on August 4, 2022, the Cultural Development Board reviewed the proposal and expressed interest in *Whispering Through a Stone*; however, the Board prioritized recommending a project to highlight in time for Art Basel, 2022, and the sculpture could not meet the deadline; and

WHEREAS, on August 24, 2022, the City Commission overall expressed interest in the proposal for *Whispering Through a Stone*; and

WHEREAS, on December 20, 2022, the Cultural Development Board reviewed a revised proposal for *Whispering Through a Stone* and made a motion recommending approval to the City Commission; and

WHEREAS, Janine Antoni is an important, globally recognized artist; and

- **WHEREAS,** Whispering Through a Stone is a unique sculpture created from stone in the likeness of a conversation chair for people to interact in a personal and meaningful way; and
- **WHEREAS,** the sculpture may be sited at various locations, the preference is for an urban environment with a staff recommendation to place the work in Merrick Park; and
- **WHEREAS,** funding of \$307,000 for the design, fabrication, installation, and related expenses is proposed through the art fund; and
- **WHEREAS,** the Arts Advisory Panel voted unanimously (7-0) to recommend the artwork *Whispering through a stone* by Janine Antoni at their meeting on August 2, 2022; and
- **WHEREAS,** the Cultural Development Board voted unanimously (7-0) to recommend the artwork *Whispering Through a Stone* by Janine Antoni at their meeting on December 20, 2022;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES AS FOLLOWS:

- **SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.
- **SECTION 2.** The City Commission does hereby accept the proposal and authorize fabrication and installation of the sculpture *Whispering Through a Stone* by Janine Antoni. The City Manager or his or her designee is authorized to negotiate an agreement with the Artist for the commissioned artwork.
- **SECTION 3.** The City Commission does hereby authorize an amendment to the Adopted Fiscal Year 2022-2023 Budget to transfer \$307,000 from the Art Fund balance and appropriate such funds toward the project.
- **SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
