A RESOLUTION AUTHORIZING SATCHMO BLUES BAR AND GRILL, INC. D/B/A FRITZ & FRANZ BIERHAUS TO UTILIZE THE PUBLIC SPACE AND MAINTAIN A TEMPORARY SOCCER WATCH PARTY SET-UP AT THE BIERHAUS PLAZA LOCATED AT 60 MERRICK WAY FROM JUNE 26, 2026, THROUGH JULY 19, 2026, IN CONNECTION WITH THE 2026 FIFA WORLD CUP.

WHEREAS, the 2026 FIFA World Cup will take place during June and July 2026; and

WHEREAS, Satchmo Blues Bar and Grill, Inc. d/b/a Fritz & Franz Bierhaus (the “Applicant”) has submitted a Special Event application requesting approval to install and maintain a temporary Soccer Watch Party set-up for 3 weeks at the Bierhaus Plaza located at 60 Merrick Way from June 28, 2026, through July 19, 2026; and

WHEREAS, the application indicates that the proposed set-up includes a large outdoor viewing screen for televised matches, associated audio equipment consisting of speakers positioned on and adjacent to the screen, tents and canopies for shade and event operations, portable restroom facilities, and other supporting equipment necessary for the operation of the viewing area; and

WHEREAS, the Applicant requests authorization to leave the viewing screen, speaker system, tents, portable restrooms, and related event infrastructure installed within the plaza for the duration of the three-week event period, rather than installing and removing the equipment daily; and

WHEREAS, as indicated in the Special Event application, the soccer matches will only be shown on each scheduled event day; and

WHEREAS, During the May 5, 2026 City Commission meeting, the Commission requested that the applicant submit a comprehensive site plan and scheduled match calendar for review, both of which have been provided as part of the Special Events application; and

WHEREAS, the Special Events Committee has reviewed the application and recommends approval, subject to conditions to ensure compliance with City regulations and the protection of the surrounding area.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

1. That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
2. That Satchmo Blues Bar and Grill, Inc. d/b/a Fritz & Franz Bierhaus is hereby authorized to utilize the Bierhaus Plaza located at 60 Merrick Way for the purpose of installing and maintaining a temporary Soccer Watch Party set-up for 3 weeks, including a large outdoor viewing screen, speaker system, tents, portable restroom facilities, and related equipment, from June 28, 2026 through July 19, 2026.
3. That the approved equipment and set-up may remain in place for the duration of the event period; however, event activities shall be limited to approved dates and times associated with the televised matches.
4. That the Applicant shall comply with all applicable City regulations, including but not limited to noise, safety, accessibility, sanitation, and maintenance requirements, and shall ensure the area is kept clean and restored at the conclusion of the event period.
5. That failure to comply with any conditions set forth by the City may result in suspension or revocation of approval.
6. That this Resolution shall become effective upon the date of its adoption herein.
