RESOLUTION 2020-___

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER TO REJECT THE AWARD APPROVED IN RESOLUTION 2020-79 (EXCEPT GROUP F-SHELVING AWARDED TO PATTERSON POPE) AND REISSUE A SOLICITATION FOR THE REMAINING ITEMS, PURSUANT TO SECTION 2-685(I)(2)(D) OF THE CITY'S PROCUREMENT CODE.

WHEREAS, the City issued IFB 2019-053 Miscellaneous Office Furniture in January 2020 and the award recommendation was approved by the Commission pursuant to Resolution 2020-79 on March 31, 2020; and

WHEREAS, the recommendation was for two bidders to receive portions of the award, Pradere Office Products (Groups A-E and G-I) and Patterson Pope, Inc. (Group F); and

WHEREAS, the items awarded to Pradere in Groups A-E and G-I have not been finalized due to selection and pricing issues; and

WHEREAS, it is recommended by the City Manager that the City Commission reject the award to Pradere and re-issue that portion in a new solicitation to secure the required furniture items; and

WHEREAS, Section 2-685(i)(2)(d) of the Procurement Code entitled "Award" states that after reviewing the City Manager's recommendation, the City Commission may reject all proposals and instruct the Procurement Officer to re-issue the solicitation; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption

hereof.

Section 2. That the City Commission accepts the recommendation of the City Manager to reject the award to Pradere for Groups A-E and G-I and re-solicit those furniture items pursuant to Section 2-685(i)(2)(d) of the City's Procurement Code.

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
