

# POLICY FOR NAMING/RENAMING CITY PARKS, OPEN SPACES, AND PUBLIC FACILITIES ~~AND ROOMS~~

## INTENT OF POLICY

To ~~provide~~establish a ~~policy~~set of standard procedures and guidelines for naming/renaming City parks, open spaces, or public facilities, ~~and rooms~~.

## GENERAL GUIDELINES

This policy does not apply to naming/renaming of streets.

~~Staff may temporarily assign~~Newly acquired or developed park properties, open spaces, or public facilities will be assigned a name based on the adjacent street, functional use, geographic feature, community name or historic significance for reference and identification purposes: in collaboration with the neighboring community through the community input process at the onset of the park development process.

The chosen name shall not conflict with similar names in whole or in part.

Every effort shall be made to avoid conflicts with neighboring municipalities, especially where streets cross municipal boundaries.

The Coral Gables City Commission shall ~~approve~~have final approval of all names by Resolution. ~~Any request to name/rename in honor of individuals or groups shall be submitted in writing to the City Manager's Office with referral to the appropriate board(s) as necessary with supporting explanation or justification. The Historic Preservation Board shall be consulted with regard to historically designated properties.~~

~~Generally, a facility will not be named after a person until after their death. An exception to naming/renaming a facility after a living person may only be made with a four/fifth (4/5) vote of approval by Commission.~~

The renaming of parks, open spaces and public facilities will be strongly discouraged. The City Commission may choose to rename an existing park if the park name is no longer in line with the criteria and guidelines and/or demeans the City in any way.

Where the name of an individual is so used, approval shall be obtained from the individual or the next of kin for such naming.

## CRITERIA/GUIDELINES FOR NAMES HONORING INDIVIDUALS OR GROUPS OR EVENTS

- ~~1. Where there has been Parks, open spaces or facilities can be named for an individual or group who has made a significant contribution to the quality of life, well-being of towards the City of Coral Gables; or~~
- ~~2. To memorialize or otherwise recognize substantial gifts and significant donors, individuals designated by donors, or individuals who have made exemplary or meritorious contributions to the City of Coral Gables; or~~
  - ~~Where there is a significant historical or cultural connection to the City and has made a major the property in question. The contribution to the historical will be defined as one or cultural preservation more of the City; or following:~~
    - ~~1. Where there is a major contribution toward Park site or facility is donated.~~
    - ~~2. Donation in the amount equal to the fair value of the land.~~
    - ~~3. Donation in the environmental preservation conservation or enhancement of amount of 50% of cost for the City; or Where there is a major contribution made to the acquisition, park development or conveyance of land or building, in question and/or contribution toward acquisition and/or development of the facility; or project as determined by the City.~~
- ~~3. Where there is a direct relationship or association that exists between the place or former place of residence of the person or group and the facility or park to be named/renamed; or~~
  - ~~Where there is a significant contribution Parks, open spaces or facilities can be named for an individual or group that has provided significant service to the community or City. The service must be defined by one or more of the following:~~
    - ~~1. Exemplary service to the betterment of a specific park, consistent community.~~
    - ~~2. Projects or programs that contributed positively to the City. Detailed descriptions of projects and programs must be provided along with at least three detailed impact statements from citizens describing how the established criteria programs or projects positively impacted their lives.~~
    - ~~3. An accomplishment, achievement or honor that brings national or international prominence to the City. Detailed explanation of the accomplishment or achievement with tangible evidence of the prominence achieved is required.~~
  - A naming will not convey or imply that the individual, individual's family or group for which the park, open space or public facility is named has any additional right to determine the development, operations or additional naming of features within the park, open space or public facility.

- Nominations will be accepted and standards for the designated considered when a nomination is received from a community-based organization in existence for at least three years. Community organizations include but are not limited to: Advisory Councils, Community Foundations, Chambers of Commerce, Rotary Clubs, and Youth Associations.
- Nominations will also be considered when received from an individual, if the nomination is accompanied by 100 signatures in support of the nomination. Only signatures from Coral Gables residents 18 years of age or older will qualify for purposes of this petition. The signature documentation must include the name, the age (18 years of age or older), full address and phone number of each resident.
- A member of the City Commission can supersede this process by presenting a naming nomination directly to the City Commission for consideration. All namings must be approved by Commission Resolution.
- Nominations will NOT be accepted in the case of any of the following conditions:
  1. Nomination duplicates the name or feature of another park-classification.
  2. Nomination endorses or advocates for a specific religion or specific religious entity.
  3. Nomination has obscene connotations.
  4. Nomination demeans or maliciously portrays any ethnic or racial group.
  5. Nomination is for an individual that has been found guilty of a felony crime.
  6. Nomination endorses or advocates a specific political organization.

## PROCEDURES FOR NAME/RENAME DESIGNATION

- ~~An~~ The City will provide a Nomination Application Form to the organization or individual, the City Commission, or group wishing to submit a submitting the naming request for a name/rename in honor of an individual or group or event. The Form must provide a written proposal to the City Manager's Office for referral to the appropriate City board(s) as necessary which contains be completed in full and will request the following minimum:
  1. Name and information: of nominating group or individual
  2. ~~name of the applicant~~
  3. identification Identification of the park, open space, facility or property to be named/renamed
  4. Proposed name

5. ~~a brief biography of the person, persons or group, or account of the historical event, if appropriate, including all other data relevant to the commemorative naming/renaming~~
6. ~~the association, if any, of the person, persons, group or event, if appropriate, with the park, site or facility to be named/renamed~~

4. Information on the nominee to include detailed biography, impact statements, detailed descriptions of contributions, service and accomplishments.

7.5. Background information which details including letters of testimonials, media materials, recommendation letters, and additional data which detail the accomplishment and/or supporting support the name designation.

8.6. Letter of approval from the individual or/next of kin or organization head for using such naming

~~Proposals must include at least three letters of endorsement supporting the application.~~

~~The City Manager's Office shall distribute the request to the Parks and Recreation Department, Historic Preservation Department, Planning Department, Building and Zoning Department, Public Works Department, Public Service Department, and Finance Department for their comments and information.~~

7. Following Signature petition (if applicable).

- The Nomination Form must be sent to the Community Recreation Director. The Community Recreation Director will then head a nominating committee that will review the nomination application. The Committee will be comprised of the Community Recreation Director and Assistant Community Recreation Director and the Director or Director's designee from the following Departments or Divisions: Landscape Services, Planning, and Historic Resources.
- The Committee will review the nomination to determine if the nomination qualifies for consideration by meeting the criteria and guidelines.
- If the Committee finds the nomination meets the receipt of comments from the various departments, criteria and guidelines, then the nomination application will be forwarded to the following Boards for review and recommendation: Parks and Recreation Advisory Board, Landscape Beautification Board and Historic Advisory Board (if applicable).
- Prior to review by the Parks and Recreation Advisory Board/Cultural Affairs Board shall review the request for a recommendation, the Community Recreation Department will notify residents within a 1000-foot radius of the park property of the naming proposal. The residents will be invited to the Parks and Recreation Advisory Board meeting at which the item is presented and will also be able to provide written statements to be read as part of the record during the Board meeting.

- Upon completion of Advisory Board reviews, the nomination will be presented to the City Commission. At least one Advisory Board recommendation to approve the naming is required to proceed to City Commission for final approval. If all boards recommend to not approve the naming, the nomination request will be denied and will not be forwarded to the City Commission.
- The City Commission may approve the waiving of any or all conditions or procedures in the naming policy.

### SIGNAGE

- The City will be responsible for coordinating the public presentation of signage to acknowledge the name/rename designation.
- The City ~~Commission~~Manager or designee shall have final approval for the selection and location of any signage, including signage text.
- Signage shall comply with the “Zoning Code” of Coral Gables.
