## **RESOLUTION NO. 2023-232**

A RESOLUTION OF THE CITY COMMISSION APPROVING AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF CORAL GABLES AND MIAMI-DADE COUNTY TO REESTABLISH DISTRIBUTION OF PROCEEDS OF THE SIX-CENT LOCAL OPTION GAS TAX FOR THE 30-YEAR PERIOD FROM JANUARY 1, 2024 THROUGH DECEMBER 31, 2053.

**WHEREAS,** Section 336.025, Florida Statutes, authorizes county governments to levy various local option fuel taxes upon every gallon of motor fuel and diesel fuel sold in the county and taxed under the provisions of Part I or Part II of Chapter 206 of the Florida Statutes pursuant to an ordinance enacted by the Board of County Commissioners; and

**WHEREAS**, in 1993, the Board of County Commissioners of Miami-Dade County, Florida, levied a six-cent local option gas tax on every gallon of motor fuel and diesel fuel sold in Miami-Dade County; and

**WHEREAS,** in 1997, The Board of County Commissioners of Miami-Dade County extended the imposition of the 1993 Local Option Gas Tax that began September 1, 1993, for a maximum period of 30 years through Miami-Dade County Ordinance No. 97-156; and

**WHEREAS**, the City of Coral Gables entered into an interlocal agreement with Miami-Dade County for the distribution of a share of the proceeds of the six-cent local option gas tax for the remainder of the 1993 Local Option Gas Tax's term; and

**WHEREAS**, by ordinance, Miami-Dade County desires to relevy the six-cent local option fuel tax authorized by section 336.025(1)(a), Florida Statutes for the 30-year period including January 1, 2024 through December 31, 2053; and

**WHEREAS**, Coral Gables and Miami-Dade County desire to amend and restate their current interlocal agreement in order to reestablish the distribution formula currently being used to distribute the local option fuel tax proceeds;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Manager and City Attorney shall execute an Interlocal Agreement between Miami-Dade County and the City of Coral Gables in substantially the attached form, and with any revisions agreed to by the City Manager and City Attorney.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
