Mayor Valdes-Fauli introduced Agenda Item A-1 which is a special recognition honoring the Teacher of the Year and Rookie Teachers of the Year. Vice Mayor Lago made the presentation stating that this year has been a particularly trying time, and as everyone is aware that teachers are faced with unprecedented challenges and have found ways of engaging students through distance learning, zoom classrooms, technological difficulties, and more than ever recognizing that the work and dedication to our children is important. It is for this reason, he wanted to ensure that the City recognize these great teachers. Additionally, he acknowledged the City's School and Communications Relations Committee for the great work they are doing and having to take a lot of time out of their busy schedules, out of their family time and work time, to serve this community and to bridge the gap between government and the schools and the great people on that Board in which the Chairman is Ariel Fernandez, and Vice Chairman is Samuel Joseph. After the presentation, Vice Mayor Lago on behalf of the City Commission thanked all the teachers that were recognized and said that their work sometimes goes without notice, but that they are beyond grateful as a community for the efforts they make with their children, tomorrow's future leaders. He thanked them again and concluded with the words "God bless all of you".

Samuel Joseph: In addressing the City Commission and those watching, Mr. Joseph thanked Vice Mayor Lago and the City Commission for honoring the teachers, and concurred with Vice Mayor Lago's sentiments that often times our teachers go unnoticed, they are living superheroes and the pandemic has confirmed that serving as teachers, counsellors, medical workers, grandmas, grandpas, therapists, whatever the students need in order to get our kids back into the schools and doing it at the risk of their own lives with a smile and humility, and it was heard today, all of them so humble, and what they got a chance to hear is the best of the best, but there are many others out there behind closed doors that are doing everything they can to make sure that we not only get our kids back at the end of the day, but that they are better and are productive members of society. Also, he is extremely proud that his City has seen its way forward in honoring those everyday superheroes. While he is aware that they have had to do this virtually because of the pandemic they are going to invite the teachers to come out to their first summer family literacy festival and hopefully they can be honored in person with their students and with their families. In closing, Mr. Joseph again thanked the teachers for the work that they do, and the Commission for seeing their way forward in doing exactly this in honoring our everyday superheroes. Mayor Valdes-Fauli and the Commission thanked Mr. Joseph, and Vice Mayor Lago reiterated his previous comments thanking him and the committee for their tireless

efforts on behalf of the City. Ms. Ana Izquierdo who was absent during the presentation to the teachers, said she was honored and thanked the City Commission. Mayor Valdes-Fauli thanked everyone and stated that it was very inspiring and well deserved.

Mayor Valdes-Fauli introduced the Agenda Item declaring April 2021 as “Earth Month” in Coral Gables.

Matt Anderson, Senior Sustainability Analyst stated that the item is being brought before the Commission in celebration of April, Earth Month and they have numerous green activities planned for Earth Month which started last Saturday with a plogging event at Matheson where over 35 people showed-up and picked up over 165 pounds of trash from within Matheson. They have already started their Earth Month activities, and with a lot planned, they will be celebrating Earth Hour on Saturday which encourages people to turn off their lights and conserve energy for that hour, and it is an international event. They will also be doing a social media campaign with the City’s Communications Department putting out environmental tips every day on social media throughout the entire month of April, and lastly on April 24th their most popular event, the household hazardous waste collection event in the City Hall parking lot which over the past six years, they have been able to collect and divert over 260,000 pounds of household hazardous waste from entering our landfills and environment. He then introduced Solange Lopez, Assistant to the City Manager to accept the proclamation as well as Enrique Bernal, who is the Manager’s appointment to the Sustainability Advisory Board who was asked to say a few words.

Mr. Bernal stated that he wanted to congratulate the City Commission and City staff for this beautiful, functional, Public Safety Building, it is gorgeous. He said that the Chief (i.e. Police Chief) informed him that in the month of April, as part of Earth Month, they will be re-instating the prescription medicine disposal program. This is one of the contributions that Sustainability has made, and additionally that the proposed statute would go in front of that building. Continuing, he said that the flame is like a sign of the renewal that we hope we are going to see coming out of this terrible pandemic. He then thanked the City Commission and wished that they all enjoy Earth Month. Mayor Valdes-Fauli thanked Mr. Bernal. Vice Mayor Lago also thanked Mr. Bernal for his involvement in everything that deals with the environment, and that it is always a privilege, and they appreciate the guidance. He said he and his family since 2016 have been doing the hour without electricity and would like as many people as possible in the community to engage in doing so, because it is not only about, obviously making a movement and pushing for more sustainability, but it is an opportunity to bring them much closer, an opportunity for him and his family to have a candle lit evening, and to spend time together. He knows that it is tough in the darkness, but it also allows them to get away from the TV, electronics, so it is a great opportunity to not only make a great statement about sustainability, but also an opportunity to reach out to their neighbors. Many of their neighbors engaging at the same moment sends a message to the community that they are the leaders, they are at

the forefront regarding conservation, and wanted everyone to know that this Commission, we partake in that and it's a great event. Mayor Valdes-Fauli then presented Mr. Bernal with the proclamation who then thanked the Mayor and City Commission.

Mayor Valdes-Fauli introduced Agenda Item A-5 declaring April 2021 as "World Autism Month" in Coral Gables.

Raquel Elejabarrieta, Director of Labor Relations and Risk Management: Ms. Elejabarrieta acknowledged the City Commission and requested to say a few words regarding the proclamation, adding that there is also the Principles of Inclusion resolution. In continuing with her presentation, she said that April has been widely known as autism month in the United States to empower autistic individuals with their families, and that today the City of Coral Gables together with many national autism organizations is shifting its language to support the growing need of acceptance within the community and will designate April as "Autism Acceptance Month" a shift from the commonly used phrase of "Autism Awareness Month". The shift in the use of terminology aims to foster acceptance of those individuals, one in every fifty-four Americans living with autism into our social fabric. In promoting acceptance, the City's Police Department has wrapped one of its police vehicles with special messages regarding autism acceptance, education, understanding and inclusion, and directed the viewers to look at the picture on the screen of the police vehicle which will be driven by Police Officer Andrew George who has a special connection with autism as his brother is on the spectrum. Also, in honor of "Autism Acceptance Month", the City will be lighting-up City Hall in blue on April 2nd which is "World Autism Day", also the City with the aid of the Police Department and Fire Department will be launching GUIDE an acronym for Gables Unique Identification During Emergencies. GUIDE is a voluntary registry where residents can provide information about their disability or special circumstance that can be crucial in guiding the City's police officers and fire fighters more effectively when interacting with that individual, primarily in cases involving safely locating an enrolled individual. Lastly, also in April, the City in collaboration with the City's Disability Affairs Board will be distributing clear masks as the one she is wearing to City businesses, as part of the City's Clear Masks or a win for Communication Campaign. More than half of communication is non-verbal, but facial communication conveys emotions and visual cues which fosters connection in a time of increasing isolation. These masks will allow

for individuals who need access to facial expressions such as the hearing impaired and those with cognitive disabilities to shop and equitably dine in Coral Gables. Also, the design on the police vehicle was a collaborative effort between the police department, specifically Sergeant Escobar, the children of Crystal Academy, UM-CARD and the City's Disability Affairs Board. They hope to unveil it during the first week of April. Ms. Elejabarrieta then introduced Fred Couceyro, Director of Community Recreation Department to highlight the excellent work that his department has been doing with accessible recreation.

Mr. Couceyro's presentation exhibited a snapshot PowerPoint of what his department is presenting to the residents because they wanted to expand their program for children with special needs. He has developed a Special Population Division and hired a full-time Special Population Coordinator including support staff for the coordinator to work on programs and functions of that division to accomplish play and accessibility for all. The three-tier program objective looked at inclusion, adaptive programming and transition period as children grow into adults. A request form for parents as to what accommodations they need to present to the division was developed and staff worked on an assessment to ascertain what could be done to provide those inclusion services. He then showed a snapshot of the numerous programs such as Adventure Day for All; Sensory Friendly showings from the Gables Cinema; Special Olympics; Bocce; Social Club for Adults - Adult Activity Center. The three-tier program includes Inclusion, Adaptive Programming and Events and Transition Support. They have worked on Tier I; Tier 2 is off and running and slowly moving into Tier 3. He also highlighted the numerous partners such as Crystal Academy, Gables Art Cinema, Gifts in Golf, and is looking for an Alliance with Therapy Dogs to have therapy dog classes. Faced with Covid-19 challenges while continuing to provide services and not lose the momentum, they concentrated on things like technology on virtual programming, for example, they had a Dance is Universal class, Zoomwork club which is their homework club, started a zoom family sign language class, in their facilities and parks they did community Bocce nights, also developed their magical parks digital playgrounds having special events at night. One of the things that they are proud of is the concept social stories which they started by having an illustration of what a family or child encounters during certain things, whether it is at an event in which there is a picture telling story illustrating what a child with special needs can expect at an event. [Applause]

Ms. Elejabarrieta requested that the proclamation be accepted by the Police Department because they played an integral part in making the City more accessible to everyone, beginning with the exceptional annual training that they received on autism, assisting in the development of the wallet card which is used to help individuals with autism communicate clearly with law enforcement, taking the lead in promoting autism acceptance with the wrapping of the police vehicle and creating GUIDE, the voluntary registry.

Commissioner Keon expressed special thanks to the City Manager and Parks and Recreation for taking the Principles of Inclusion and giving it life. When they started with all the issues of Principles of Inclusion it was really Craig Leen that was so inspirational in helping them get there, and after doing it, she has a grandson who is on the autism spectrum, and it really paid off going forward, because it has brought great benefit to her family. Her grandchild went to Crystal Academy for a year after transitioning to a regular class at Coral Gables Elementary and goes to the Youth Center to play. So, everything that Craig started has brought great benefit to her and her family and thanked them.

Ms. Elejabarrieta thanked Commissioner Keon and acknowledged Vanessa Liebl, Chairwoman and Mary Palacio-Pike-Board Member of the Disability Affairs Board and President of Crystal Academy who were present in support of the City and the Police Department.

Mayor Valdes-Fauli introduced the Agenda Item A-6 regarding Officer Robert Thomson, recipient of the Coral Gables “Officer of the Month Award”, for the month of January 2021 and Police Chief Edward J. Hudak made the presentation.

James E. Hudak, Police Chief stated that on January 6, 2021, at approximately 8:58 a.m., while driving on Southwest 8th Street, using the City’s Information Technology’s automated license plate recognition reader, Police Officer Robert Thomson was alerted to a Black BMW that was reported stolen the night before from the City of Miami. Police Officer Thomson followed the vehicle down Columbus Boulevard and using his years of experience, he radioed in the other officers that were in the area. Upon stopping the suspects, he was able to safely remove the driver and two other occupants from the vehicle and in searching the vehicle he found a backpack with 45 stolen credit cards and other property stolen from individuals from the City of Coral Gables and throughout. Additionally, one individual in the vehicle was also wanted for the theft of cargo by the Miami-Dade Police Department. It is because of Police Officer Thomson’s exceptional knowledge of the City’s geography in expediting this, his rapid response and tactical mindset approach to the incident, he was able to swiftly apprehend these offenders. This is a nomination from his sergeant who is also present today, Erasmo Lopez. It is because of his actions in January that he is being recognized today. Chief Hudak then presented Officer Thomson with his award.

Police Officer Thomson upon accepting his award thanked the City Commission for the opportunity to be recognized and for 25 years of service and still having fun out there. At the time of the arrest of the suspects, there was a probationary officer with him who was on her second month, and it was a good opportunity to get some experience with a felony type take down, and overall, it was a good thing. He then acknowledged his mother, ex-Mayor Thomson, father and his son, Brenton in the audience and thanked the City Commission. Mayor Valdes-Fauli thanked him on behalf of the City Commission and said it was well-deserved.

Mayor Valdes-Fauli introduced Agenda Item A-7 in recognition of Ray Corral and Alina Meledina for their donation of orchids on Country Club Prado and Commissioner Fors, Jr., made the presentation. The recognition is the result of an incident involving a series of orchid thefts which occurred on Country Club Prado during Covid, and he wanted to acknowledge Alina and Ray for not only organizing the neighborhood and donating orchids to replace the stolen ones, but having organized the entire initiative on their block, Country Club Prado by installing beautiful orchids in front of some of the trees in front of the swales. Alina and Ray are tremendous fans of Coral Gables, amazing residents, and that is only one of the many things they have done, including the tremendous support they have given to our restaurants and our local foundations during Covid, thus the reason for the Certificate of Appreciation and waited until they could appear in person to accept the certificate. An interesting thing about Ray, is that they live in a beautiful historic home on Country Club Prada where M.B. Garres, a former Commissioner of Coral Gables during the 1930s lived.

Mr. Corral stated that his company designs, fabricate and install mosaics and specializes in swimming pools more than anything else, and jokingly said that he could elaborate on it all day if they want (laughter). Also, what they do is, they have gotten a lot of commissions to work with historical designated homes and what he has done, even with their own home that is designated, he works with the release and the architecture of the actual house and the designs for the swimming pools which is not connected to the actual home. So, when people want to redecorate their home with some sort of Versace design that does not go well with the architecture and the integrity of the actual original house and work in preserving the architecture and release of the designs and redesign it using the tile work for the release of the elevation of the home which is something very important to them and seems to be

going very well. It is a huge invention, and Coral Gables Magazine did a huge article on what he does, and it has been interesting and great, and thanked the City Commission.

Deena Bell-Llewellyn, City's Landscape Architect- Public Works Department stated that in celebration of Arbor Day, which is April 30th, there is a presentation that is two-fold.

The Landscape Advisory Beautification Board yearly awards being presented today because during Covid, they were not able to have their annual Arbor day celebration in the schools, which they planned to have at Sunset Elementary, and today honors the residents who did beautiful gardens. She then introduced Liz Parnes, the Chairwoman of the Landscape and Beautification Advisory Board to say a few words.

Ms. Elizabeth "Liz" Parnes stated that the board is made up of members representing each of the City Commissioners, she represents Michael Mena, and they are proud of the work that they do focusing on the aesthetics of all open spaces in the beautiful City of Coral Gables. Additionally, they organize and work with the Coral Gables Garden Club to present the Arbor Day event at each of the schools they select and Sunset Elementary was selected last year and they were unable to hand out those awards. She requested that the award winners join them and there are six or seven homeowners who win each year, and they proudly receive their awards and are excited about that as well as an opportunity to see schools' presentations regarding Arbor Day which is quite nice. She noted that a lot of time is spent looking at plans for the open spaces for approval and making sure that they continue with the

emphasis that they meet the needs of the community as well as the safety requirements needed by the City and thanked the City Commission.

Ms. Bell-Llewellyn then showed a PowerPoint presentation of the homes chosen for an award and gave a short background of each property awarded for 2020 noting that the Board has already started the process of scouting the five zones of the City for the winners of this year.

The second presentation entitled “The State of the Canopy” is about the City and urban forest initiatives, and the City has the most amazing tree canopy in which they are proud of and blessed to have. Ms. Bell-Llewellyn went on to explain the history behind Tree City USA and the part Coral Gables has played for 36 years as an active member, using an illustrative PowerPoint presentation consisting of diagrams and charts covering all aspects of trees including Tree Species Diversity, Canopy Coverage, Tree Planting program (removal and plantings), Tree Pruning (before and after), responsibility as well as the City’s App regarding tracking and location of all trees throughout the City. At the completion of her presentation, she introduced Judy Mangarsarian, president of the Coral Gables Garden Club.

Ms. Mangarsarian recognized the Mayor and City Commissioners and said it was an honor to accept the Arbor Day presentation on behalf of the Coral Gables Garden Club. The Club is almost 100 years old and has always been committed to enhancing and beautifying the City, and many of its members serve on the Landscape and Beautification Board. It is one of their favorite events having been celebrated in Coral Gables over 50 years ago and thanked the City for their partnership and educating the children on the importance of trees and gave the history of the origins of Arbor Day which began on April 10, 1872 in Nebraska City, with the planting of one million trees and this tradition today is celebrated in all 50 States in appreciation of trees and forests, with children being an important part of the event. This year there will be a virtual celebration at Sunset Elementary School where a Lignum Vitae tree will be planted on May 3rd. She then presented the City with a check for \$1,000.00 from the Garden Club for the planting of the Lignum Vitae tree and to honor deceased members who have died since the last Arbor Day, 2019. Namely, Rebecca Calvert, Betty Fisk, Hilda Lawhorn, Arva Moore Parks McCabe, Martha Hobbs and Jean Hicks. In setting aside one day a year to celebrate the value of trees is a wonderful and worthy effort because of their shade, beautify and the many benefits they bring to the environment is priceless. She thanked the City Commission for partnering with them in this celebration and wished them a happy Harbor Day.
