RESOLUTION 2020-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA, REAPPOINTING ARAMIS “MITCH” ALVAREZ AS THE SPECIAL MASTER PRESIDING OVER QUASI-JUDICIAL PUBLIC HEARINGS FOR THE BOARD OF ARCHITECTS PURSUANT TO SECTIONS 2-302 AND 2-303 OF THE CORAL GABLES ZONING CODE.

WHEREAS, Sections 2-302 and 2-303 of the Coral Gables Zoning Code outline the qualifications and responsibilities of the Special Master presiding over quasi-judicial public hearings for the Board of Architects; and

WHEREAS, the Special Master must have been a registered architect or landscape architect responsible for the design and construction of projects within the City of Coral Gables during the last five (5) years and shall have a minimum of ten (10) years’ experience in their profession and shall either be a resident or have their principal place of business in the City of Coral Gables; and

WHEREAS, Aramis “Mitch” Alvarez was appointed as the Special Master presiding over quasi-judicial public hearings for the Board of Architects in Resolution 2017-257 and has served the City well in that capacity and Mr. Alvarez meets and exceeds the qualifications and responsibilities outlined in the Zoning Code and is a longtime resident with an illustrious career designing many significant buildings within the City of Coral Gables and the greater Miami area; and

WHEREAS, the Special Master appointment shall be for a two (2) year term, the individual shall be appointed by the City Manager in consultation with the Board of Architects and approved by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission hereby ratifies the City Manager’s reappointment of Aramis “Mitch” Alvarez as the Special Master presiding over quasi-judicial public hearings for the Board of Architects for a two (2) years term.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
