RESOLUTION 2009-234

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE BLUE ROAD ROUNDABOUT PROJECT TO MAGGOLC, INC., PURSUANT TO SECTION 2-828 OF THE PROCUREMENT CODE, ENTITLED "CONTRACT AWARD", INVITATION FOR BID (IFB) 2009.05.07.2 AND THE COMMUNITY SMALL BUSINESS ENTERPRISE LEVEL 1 SET-ASIDE REQUIREMENTS, IN THE AMOUNT OF \$145,642.70 (ONE HUNDRED FORTY FIVE THOUSAND SIX HUNDRED FORTY TWO DOLLARS AND SEVENTY CENTS).

WHEREAS, the Blue Road Roundabouts Project is part of a joint participation agreement between the City of Coral Gables and Miami-Dade County Small Business Development Office, which provides that the contractor selected for this project will meet Community Small Business Enterprise (CSBE) Level 1 set-aside requirements; and

WHEREAS, on June 5, 2009 the Procurement Division of Finance formally advertised, issued and distributed the Blue Road Roundabouts Invitation to Bid (IFB) 2009.05.07.2; and

WHEREAS, on June 12, 2009, a non-mandatory pre-bid conference was held and six (6) prospective bidders attended, with a total nineteen (19) prospective bidders who downloaded the bid document from the website or picked up the document from the Procurement Division of Finance; and

WHEREAS, On June 25, 2009 five (5) bid responses were submitted by: Solution Construction, Inc., Wrangler Construction, Inc., ABK Construction, JVA Engineering, and Maggolg, Inc. and of those that responded three (3) bids were deemed nonresponsive by the Miami-Dade County Public Works Department who reviewed the bids on behalf of Miami Dade County Small Business Development Office; and

WHEREAS, on July 28, 2009 confirmation was received from the Miami-Dade County Public Works Department accepting Maggolg, Inc. as the lowest responsive, responsible bidder meeting Community Small Business Enterprise Level 1 Set-Aside requirements making it eligible to be awarded a contract to complete the Blue Road Roundabout Project; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, pursuant to Procurement Code Section 2-828, entitled "**Contract Award**," contract awards for supplies and services exceeding \$100,000.00 shall be approved by the City Commission, and it is recommended by the Chief Procurement Officer that this Contract Award for Maggolg, Inc., be approved;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission does hereby direct the City Manager to authorize the Chief Procurement Officer to award the Blue Road Roundabout Project to Maggolg, Inc. pursuant to Section 2-828 of the Procurement Code, entitled "**Contract Award**", Invitation for Bid (IFB) No. 2009.05.28 and the Community Small Business Enterprise (CSBE) Level 1 set-aside requirements, in the amount of \$145,642.70 (One Hundred Forty Five Thousand Six Hundred Forty Two Dollars and Seventy Cents).

SECTION 3. That this resolution shall become effective upon the date of its passage and adoption herein.
