I just wanted to kind of get a little -- put it on the record the contract amount and also the reason for the bid waiver. I think it's important that we offer a little bit clarity of that on the record, especially with this being a Zoom meeting and everything.

City Manager Iglesias: Vice Mayor, this is Visual Computer Solutions. It's the police officer (INAUDIBLE) system. It is for maintenance of that system. I will have Celeste Walker from Procurement answer your questions.

Vice Mayor Lago: Thank you.
