**RESOLUTON NO. 2010-168**

RESOLUTION AUTHORIZING EXPENDITURES IN THE AMOUNT OF \$8,000.00 FROM PREVIOUSLY ENCUMBERED STATE FORFEITED ASSET FUND (F.A.F.) MONIES TO SUPPORT THE ACTIVITIES AND PROGRAMS ASSOCIATED WITH THE DRUG ABUSE RESISTANCE EDUCATION (D.A.R.E.) INSTRUCTION CONDUCTED BY THE CORAL GABLES POLICE DEPARTMENT YOUTH RESOURCE UNIT.

**WHEREAS**, The Coral Gables Police Department's investigations of criminal activity produce forfeited funds, both related and unrelated to its participation in the South Florida Money laundering Strike Force operations; and

**WHEREAS**, the Coral Gables Police Department may lawfully retain at the conclusion of the legal proceedings the forfeited funds as authorized under Florida State Statute 932.7055; and

**WHEREAS**, the City Commission, under Resolutions No. 2008-102 and 2009-227 encumbered Forfeited Asset Funds for future expenditures or donations to school resource officer, crime prevention, safe neighborhood, drug abuse education or drug prevention programs or as the City Commission deems appropriate; and

**WHEREAS**, the Coral Gables Interim Police Chief, Richard J. Naue Jr., and the Coral Gables Finance Director, Donald G. Nelson, attest to have deposited the sum of \$8,000.00 in said forfeited funds into the Coral Gables Forfeited Asset Fund; and

**WHEREAS**, the FAF Committee met on August 16th, 2010 and followed the FAF Committee operating procedures adopted on July 23, 2002, and

**WHEREAS**, The FAF Committee approved the Coral Gables Police Chief's request to expend the available funds on the specific items listed below on this resolution;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby direct the City Manager to authorize the Finance Director to expend \$8,000.00 from State Forfeited Asset Fund monies previously encumbered under Resolutions 2008-102 and 2009-227, to support the activities and programs associated with the D.A.R.E. instruction conducted by the Youth Resource Unit of the Coral Gables Police Department; the use of these funds is in accordance with the provisions of Florida State Statute 932.7055(5)(c)(3) that the proceeds and interest from assets forfeited as a result of criminal investigations shall be used for school resource officer, crime prevention, safe neighborhood, or drug abuse education and prevention programs.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


