**RESOLUTION NO. 2020-249**

A RESOLUTION OF THE CITY COMMISSION APPROVING ENTERING INTO AN AGREEMENT WITH EVERGREENE ARCHITECTURAL ARTS TO COMPLETE A PUBLIC ART MAINTENANCE ASSESSMENT; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2020-2021 ADOPTED BUDGET TO TRANSFER \$8,169.00 FROM THE ART IN PUBLIC PLACES FUND BALANCE AND APPROPRIATING SUCH FUNDS TO PUT TOWARD THE COST OF THE PROJECT.

**WHEREAS**, public artwork in the City's collection requires a professional condition assessment, maintenance recommendations and schedule for ongoing care; and

**WHEREAS**, professional conservation and restoration professionals were approached and asked to submit bids for the assessment; and

**WHEREAS**, staff recommends contracting with Evergreene Architectural Arts for the project at an estimated fee of \$8,169.00; and

**WHEREAS**, an amendment to the Adopted Fiscal Year 2020-2021 Budget is required to transfer the \$8,169.00 from Art in Public Places fund balance, and appropriate such funds to put toward the project;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.


**SECTION 2.** The City Commission does hereby authorize the negotiation and execution of an agreement with Evergreene Architectural Arts for the public art maintenance assessment, consistent with the City's standard professional services agreement, with such modifications as may be approved by the City Manager and the City Attorney, consistent with the Commission's intent.

**SECTION 3.** That the Commission does hereby authorize an amendment to the Adopted Fiscal Year 2020-2021 Budget to transfer \$8,169 from Art in Public Places fund balance; and appropriate such funds to put toward the project.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.


