

**EXTENSION OF THE CONTRACT BETWEEN THE PARTIES TO  
PROVIDE SECURITY GUARD SERVICES**

This EXTENSION OF CONTRACT TO PROVIDE SECURITY GUARD SERVICES ("extension") is made and entered as of the 27th day of August, 2014, by and between The City of Coral Gables ("City") and World International Security, Inc., ("Professional").

**RECITALS**

**WHEREAS**, the City and Professional have previously entered into a certain Contract dated August 27, 2009 ("contract") whereby the Professional provides Security Guard Services at the City's 2800 SW 72<sup>nd</sup> Avenue facility and security guard services as needed in the City for various activities and events at other City facilities; and

**WHEREAS**, the contract expires on August 27, 2014 and parties desire to extend the contract through October 31, 2014 ("the extension period") to provide time for Invitation for Bids (IFB) process to be completed and for a new contract to be approved, and to authorize an extension of the existing contract; and

**WHEREAS**, the Professional has agreed to continue to provide Security Guard Services through an extension of the aforementioned contract for an additional period through October 31, 2014 under the same terms and conditions of the contract.

**NOW, THEREFORE**, in consideration of the promises and the mutual covenants contained herein, the City agrees to retain the Professional during the extension period.

1. **INCORPORATION OF RECITALS.** The foregoing recitals are true and correct and are incorporated herein. All terms used herein shall have the meaning ascribed to such terms in the contract, unless defined otherwise herein.

2. **TERM.** The parties hereby acknowledge that the extension period shall be August 27, 2014 through October 31, 2014, unless terminated earlier pursuant to the terms of the contract. Thereafter, the term will be automatically renewed on a month to month basis at the City's option.

All other terms and provisions of the contract are hereby confirmed and shall remain in full force and effect, except as modified herein.
