Mr. Carta: For the record, I am Carlos Carta, 715 Anastasia Avenue. Mayor, Vice Mayor, Commissioners, staff, I stand here today as a constituent, a neighbor, and for many of you a friend, to share a few things that are top of mind with my neighbors. Once again, Somerset Academy located at 724 Anastasia Avenue failed to meet its annual obligation under a legal settlement agreement with me, our neighbors, and the Biltmore Neighbors Association. Continuing a pattern of negative behavior. Since the city has decided to review Somerset expansion application without even asking if they have met with the neighbors. I promise you that this will open up a path for Gulliver, Riviera Day School, St. Phillips, Santa Teresita, to come and ask for an expansion. I encourage you here to let Academica and Somerset know that this expansion doesn't belong in the Biltmore neighborhood.
