# NOTICE OF CITY COMMISSION ITEM RENAMING OF STREETS WITHIN PINE BAY ESTATES

## CITY OF CORAL GABLES, FLORIDA

A request for the renaming of streets within the Pine Bay Estates Special Taxing District will be presented for approval at the regular City Commission meeting in the Commission Chambers, City Hall, 405 Biltmore Way, Coral Gables, Florida on Monday July, 25, 2022, beginning 9:00 a.m.

#### **Background:**

A letter of intent, in accordance with the City of Coral Gables Special Taxing District Amendment Policy, was filed with the City on April 12, 2022. The petition was filed by the Pine Bay Estates Homeowners Association with over 20% of the homeowners support. This request does NOT seek an amendment to the District and solely seeks to determine the level of support in the community for street renaming. The Special Taxing District Amendment process is being used as a guideline since the District and the renaming area share the same boundaries.

The petition language was presented to the City Commission on May 31, 2022 and approved. The petitioners have returned the petition to the City with over 50% of the property owners in support. The item will now be considered by the City Commission.

### **Proposed Street Renaming:**

Renaming the current street names in the Pine Bay Estates area to conform with Coral Gables Street Signage as follows:
