

are in violation of the following sections of the City Code of the City of Coral Gables:

Sec. 58-48. - Duty of abutting property owners to repair

(a) Sidewalks in the city that are broken, cracked or otherwise in such condition as not to present a smooth, continuous surface, are a nuisance. It shall be the duty of the owner of property abutting defective sidewalks to remedy such defective condition.
(Code 1958, § 28-13; Code 1991, § 22-47; Code 2006, § 54-81; Ord. No. 791, § 2, 7-21-1953; Ord. No. 2309, § 1, 5-8-1979)

The following steps should be taken to correct the violation:

Remedy: Comply with Sec. 58-48. (a) - apply for and obtain a permit to repair damaged brick pedestrian crosswalk which connects SE and SW corner of Galiano St and Palermo Ave.
